

Regular Session
March 10, 1997

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as read.

OLD BUSINESS:

6483 On the motion by Judge Bobbitt, second by Allen Martin, the Court approved the following appointments to the Hunt County Historical Commission for the 1997-98 term:

6484 On the motion by Ralph Green, second by Kenneth Thornton, the Court approved the Final plat for Highland Ridge Subdivision in Pct 2.

6485 On the motion by Judge Bobbitt, second by Green, the Court approved action on policy and procedure for the use of county facilities. Hunt County will require an application be filed 15 days prior to Commissioners Court meeting, for each organization, other than a governmental entity, wishing to use our facilities. Proof of financial responsibility and proof of IRC per State statute 501 will also be required. The Court will act on each application received. Political parties must also make applications. Applications will be filed in the County Clerk's Office.

6486 'Possibly take action on request from the Sheriff's office to purchase equipment:' Don Anderson, Hunt County Sheriff, submitted to the Court a line-item budget for Drug Seizure Funds, an account separate from the county budget, for the purchase of the following equipment:
flash lights
portable radios
rain coats
new uniforms
computer for the front office. The Court approved on the motion by Green, second by Martin.

6487 On the motion by Green, second by Thornton, the Court approved request to advertise for gasoline and diesel.

6488 On the motion by Green, second by Jim Walker, the Court accepted all 3 bids on box culverts received from R.L. Butler, J.L. Clack and Yoder Construction. Commissioners office to check with the suppliers for specifications. Bids on file in the County Auditor's office.

6489 On the motion by Green, second by Walker, the Court accepted all 3 bids on concrete clear span bridges received from R.L. Butler, J.L. Clack and Yoder Construction, per state specifications. Bids on file in the County Auditor's office.

— The Court heard from Bob James, representative of Aramark, concerning their service and maintenance with each precinct.

6490 'Possibly take action on proposed quitclaim of state's interest in surplus channel easement on FM 1565:' On the motion by Green, second by Martin, the Court approved resolution stipulating that the channel easement to be quitclaimed, no longer needed for citizens for road purposes.

— 'Possibly take action on request to abandon maintenance on CR2670 and allow it to become a private road:' The Court stated a public hearing is required before the road can be declared private. Judge Bobbitt to set time for hearing, must be posted for 10 days. Commissioner Green to contact each of the property owners along the road.

6491 On the motion by Green, second by Thornton, the Court approved request from FEC to construct electrical power distribution facilities along the following county roads in Pct 2: CR2230, 2269, 2438, 2546, 2578, 2618, 2632, 2646 and 2666.

6492 On the motion by Walker, second by Martin, the Court approved request from FEC to construct electrical power distribution along the following county roads in Pct 3: CR3116, 3221, 3225, 3318, 3510 and 3602.

6493 On the motion by Green, second by Walker, the Court approved request from GTE to bury telephone cable along R-O-W on CR 2216, 2512 and 3208 with standard disclaimers.

HEAR AND DISCUSS REPORTS:

The Commissioners discussed the need for emergency repairs, replacing co-axle and installing new antenna, at the county's radio communication tower.

6494 On the motion by Martin, second by Thornton, the Court approved accounts payable.

6495 On the motion by Walker, second by Thornton, the Court approved line-item budget transfers.

ADDENDUM:

6496 On the motion by Martin, second by Thornton, the Court approved yearly option for preventive elevator maintenance service with Unitec.

6497 On the motion by Green, second by Martin, the Court approved yearly option for typewriter maintenance with Greenville Business Machines.

6498 On the motion by Walker, second by Green, the Court approved yearly option for road oil with Billy Todd Bryan of Bryan and Bryan.

6499 On the motion by Green, second by Thornton, the Court approved yearly option for seal coating with Coke Asphalt and Argon Asphalt.


PERSONNEL AND PAYROLL:
