

Regular Session  
May 12, 1997

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved with change noted.

OLD BUSINESS:

6544 'Possibly take action on gasoline commercial card readers:' After a brief discussion between the Court and the County Sheriff concerning the difference in the two bids received, motion was made by Kenneth Thornton, second by Allen Martin, agreement was made to remain with Daniel Oil Company.

NEW BUSINESS:

6545 On the motion by Jim Walker, second by Ralph Green, the Court approved an Interlocal Agreement between Pct.3 and the City of Campbell to help spread rock received from the State. The Commissioners office to provide upgraded agreement for the members of the Court to sign.

— Joyce Barrow, Hunt County Tax-Assessor Collector made presentation of the Semi-Annual report, which indicated for the first 6 months of this fiscal year her office has collected 96% of the projected tax and fee revenue, \$7,241,078, which had been budgeted, and 54% of total projected county budget of \$14,670.

6546 On the motion by Judge Bobbitt, second by Ralph Green, the Court approved request to advertise for 1 or more mowers for all precincts.

6547 'Possibly take action on transferring contract responsibilities to the Personnel Office:' On the motion by Walker, second by Green, the Court approved transferring the full-cycle of the bid process (advertising, receiving bids & retention of sealed bids) from the County Auditor to the Personnel/Loss Control Coordinator. The County Auditor will audit the bid process.

6548 On the motion by Walker, second by Thornton, the Court approved request to advertise for bids on buy-back clause on Cat Motorgraders in Pct.3.

6549 On the motion by Martin, second by Walker, the Court approved resolution authorizing the County to charge an additional \$30 for filing civil suits and \$15 upon the conviction of any criminal offense filed with the County Clerks Office, in compliance with Sec.51.702 Government Code, V.T.C.A., as amended, be collected and sent to the Comptroller of Public Accounts monthly for deposit in the judicial fund. This will allow a \$25,000 yearly increase with \$5,000 net for administrative costs and \$20,000 to be returned to the County for the County Court at Law Judge.

6550 On the motion by Green, second by Martin, the Court approved the final plat for Hart Creek Estates in one subdivision located in Pct.2. Jim Hart to deliver file-marked plat to the Appraisal office.

6551 On the motion by Green, second by Thornton, the Court approved request to construct a single phase 14.4 K.V. line along the east side of CR2146 to Cap-Rock Electric with usual stipulations.

6552 On the motion by Walker, second by Martin, the Court approved request to bury telephone cable along R-O-W on CR 3622 in Pct.3 to GTE with usual stipulations.

6553 On the motion by Walker, second by Martin, the Court approved request to bury telephone cable along R-O-W on CR 3620 in Pct.3 with usual stipulations.

HEAR & DISCUSS REPORTS:

— Hunt County Sheriff Don Anderson along with Chief Deputy Phillip Killgore gave the Court a performance report of the first 5 months in office. Hunt County Clerk Linda Brooks updated the Court on a recent reorganization of the county deed room with help from our maintenance department and jail trustees.

6554 On the motion by Martin, second by Thornton, the Court approved accounts payable.

6555 On the motion by Martin, second by Thornton, the Court approved line-item budget transfers.
