### Regular Session June 23, 1997

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as revised.

### OLD BUSINESS:

(582) On the motion by Jim Walker, second by Ralph Green, the Court approved application for junkyard permit # 4 in Pct 3 to Archer Auto, located at 9751 FM 751 in Quinlan, Texas, which is to be a storage area, as well as a new parts store.

## NEW BUSINESS:

Edith Archer, with the West Tawakoni Merchants Association, made presentation of Resolutions passed by area entities in regards to Hunt County access to Lake Tawakoni State Park. The only entrance to the 401 acre park, located in the south part of Hunt County, is through Van Zandt County. Request was made for Hunt County to help with this entrance. Judge Bobbitt accepted Resolutions, stating the planned entrance would be an extension off of an existing county road and the right of way would have to be purchased solely by Hunt County.

6583 On the motion by Allen Martin, second by Green, the Court approved tax abatement for CCI, a firm that duplicates audio and video cassettes, located in the Greenville Industrial Park. This firm is planning to build a 22,000 sq. ft. facility at the approximate cost of \$1 million; abatement would be on this building and not the \$1.2 million in equipment inside the building. Judge Bobbitt stated to the Court all qualifications have been met. If the property is ever sold, abatement agreement is not transferred, issue would have to be brought back before the Court requiring to meet the same criteria.

6584On the motion by Kenneth Thornton, second by Green, the Court on unanimous vote agreed to withdraw from the Chaparrals Rails to Trails Resolution. Decision was made after the Court heard recommendations from the fact finding committee formed to discuss and review this issue and our county attorney. The Court feels Rails to Trails places too much responsibility on the county and the liability is too great.

'Discuss concerns regarding the County Trapper:' Don Isenburg and Paul Burns were present in court stating they felt money paid to the county trapper could be better spent on county roads. Commissioner Martin told the Court in the north-east part of the county, the trapper has been an asset. Agreement was made to review the need for a trapper in upcoming budget workshops, report of results to be given to the Court at that time by Mr. Dickens-Co.Trappe:
