## Regular Session July 14, 1997

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:

6594 On the motion by Ralph Green, second by Allen Martin, the Court approved re-negoiated contract with Southwestern Bell. Barbara Osbourn, with SWB advised the Court that our old system was not adequate. County Sheriff Don Anderson told the Court his office had problems with the imaging system in the jail concerning fingerprints and mug-shots. Under the new contract system upgrading will be done by SWB-furnishing \$30,000 in new equipment and \$10,000 in maintenance at no costs to the County. This contract will be for 4 years, ending January 1, 2001.

6595 On the motion by Jim Walker, second by Kenneth Thornton, the Court approved exchange of property located near E-systems between Hunt County & the City of Greenville, which will facilitate the airport entrance. (City's 14.87 ac. (Pct 3) appraised at \$3,304 an acre)

6596 On the motion by Green, second by Walker, the Court approved resolution in support of TxDot extending improvements on State Hwy 66 from FM 1570 to Loop 315 within the city limits of Greenville. Judge Bobbitt to prepare resolution and letter of support.

'Possibly take action on recommended changes to the Lake Tawakoni Planning Commissions Zoning Ordinance:' Placed on OLD BUSINESS for August 11th meeting.

(6578 On the motion by Green, second by Martin, the Court approved Health Service Agreement between the Hunt County Health Department and the Cities of Caddo Mills, Campbell, Celeste, Commerce, Quinlan, West Tawakoni, Wolfe City and Lone Oak for food service inspection and licensing agreement.

'Possibly take action on resolution supporting Texson Management Group Inc. application and proposal to the Tx Dept of Criminal Justice to locate a secure residential multi-use facility in Hunt County:' Several area residents were present in court with over 500 signatures protesting this proposal. Commissioner Green and Judge Bobbitt both concur since the Court has not received any information concerning this application and proposal, agreement was made to drop from the agenda at this time. A public meeting is to be held in Caddo Mills to allow any citizens, whether inside or outside the municipality, an opportunity to voice their support or non-support. If the City of Caddo Mills advocates this proposal, then the County will look into this matter.

6599 On the motion by Thornton, second by Green, the Court approved yearly copier maintenance agreement (without toner) with Copy Products Inc..

6600 On the motion by Thornton, second by Green, the Court approved Judges, Alternate Judges and Polling locations for the August 9th-Special Constitutional Amendment Election which was presented to the Court by County Clerk Linda Brooks.

(6(60) On the motion by Judge Bobbitt, second by Green, the Court approved adoption of a nuisance dog ordinance as stated in Chapter 822 of the Health & Safety Code: Subchapter (A) allows for the seizure & destruction of dogs which run loose attacking humans and some forms of livestock, Subchapter (B) prohibits dogs from running loose that have previously attacked animals. For: Bobbitt, Green, Thornton & Walker. Opposed: Martin. Amendment: Commissioners agreed this would pass subject to the recension of petition for yote on Subchapter C.

6602 On the motion by Martin, second by Walker, the Court approved Resolution recognizing the Tawakoni Basin Economic Development Corporation and to support the same organization in its endeavors to promote the towns, cities and counties of the Lake Tawakoni area.

6603 On the motion by Judge Bobbitt, second by Walker, the Court approved Resolution in support of a study to obtain R-O-W acquistion for the extension of FM Road 1385 to the Lake Tawakoni State Park.

6604 On the motion by Green, second by Martin, the Court approved annual lateral road and bridge mileage certification forms (1100 miles).

6605 On the motion by Green, second by Walker, the Court approved request to bury telephone cable along R-O-W of CR2638,2260,2446,234 & 2500 in Pct 2 with usual stipulations.

6606 On the motion by Walker, second by Martin, the Court approved request to bury telephone cable along R-O-W of CR3409 in Pct 3 with usual stipulations.

6607 On the motion by Martin, second by Thornton, the Court approved request to bury telephone cable along R-O-W of CR4423 in Pct 4 with usual stipulations.
