

Regular Session
Commissioners Court Meeting
November 24, 1997

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:

_____ 'Hear from the Hunt County Appraisal District concerning platting process:' Gayle Martinez was present to discuss the problem they are still having of not receiving all mylars of final plats (appraisal office doesn't need mylar on preliminary plats) which have been approved by the Court and filed in the County Clerk's Office by the developer. Once the developer leaves the clerks office with the mylar intended for the Appraisal Office it has not always been delivered. Agreement was made after the final plats are approved by the Court, the two mylars will be taken to the County Clerk's Office for filing---1 will be kept by the clerks office for filing and the other will be picked up by the Appraisal Office on a weekly basis. This will insure they receive their mylar.

6738 On the motion by Judge Bobbitt, second by Ralph Green, the Court authorized the county auditor to make an expenditure item for JP security (Justice Court Security) to appropriate \$500 out of court appointed attorney line-item funds for a court baliff. Adding amendment: to pay temporary baliff up to \$12 per hour to be determined by the magistrate. Request was made that complete and separate records documenting baliff expense be sent to the county auditor.

6739 On the motion by Kenneth Thornton, second by Allen Martin, the Court approved bid for 1 3/4" flex-base rock originating from Meridian at Willis, Oklahoma at \$4 per ton.

_____ 'Request permission to transfer \$15,000 from bridge fund of Pct 3 to equipment fund for purchase of a Gallion Motor Grater from TxDot approximate effective date 12-1-97:' To be approved in line-item budget transfers.

_____ 'Possibly take any action necessary on temporary jail facility:' Judge Bobbitt advised the Court 8-10 loads of dirt are being delivered at this time and by next week we should have a slab for the temporary jail.

_____ Judge Bobbitt read a letter of thanks sent to the Court from David Gibson of the North East Texas Children's Museum concerning the work recently done by the Hunt County inmates of mowing grass, trimming trees and general clean-up.
