

REGULAR SESSION  
COMMISSIONERS COURT MEETING  
FEBRUARY 23, 1998

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as submitted.

NEW BUSINESS:

- 6796** On the motion by Jim Walker, second by Allen Martin, the Court approved the final plat for Travis Heights Subdivision in Pct.3 containing 5--2.2405 acre tracts with utilities available (not in flood plain) as presented by Richard Merrington.
- 6797** On the motion by Walker, second by Ralph Green, the Court approved the preliminary plat for the Schilling Estates Subdivision in Pct.2 containing 19--2 acre tracts (within flood plain) as presented by Wisdom Engineering. Determined in court to be in Pct.3. \*
- 6798** On the motion by Green, second by Kenneth Thornton, the Court approved the preliminary plat for the Cottonwood Estates Subdivision in Pct.2 containing 14--2 acre tracts (partially in flood plain) as presented by Wisdom Engineering. The Court also discussed the installation of aerobic systems especially for Lots 7 & 8. Judge Bobbitt to contact Health Dept. on requirements. Commissioner Green stated before coming back to court for the final plat letters would be required from the utility companies and from the Superintendent of Caddo Mills Schools stating notification has been received concerning new subdivisions.
- 6799** On the motion by Martin, second by Walker, the Court approved request to bury telephone cable along R-O-W of CR4413 & 4405 to United Telephone of Texas with usual stipulations.
- 6800** On the motion by Green, second by Thornton, the Court approved request to bury telephone cable along R-O-W of CR2297 & 2246 in Pct 2 to GTE with usual stipulations.
- 6801** On the motion by Walker, second by Martin, the Court approved request to bury telephone cable along R-O-W of CR3515 in Pct.3 to GTE with usual stipulations.
- 6802** On the motion by Judge Bobbitt, second by Thornton, the Court approved Proclamation to recognize the Farm Bureau Organization and to designate March 16-20, 1998 as Farm Bureau Membership Week in Hunt County.

-----'Possibly take action on temporary jail facility:' The Court discussed the progress of the jail which is near completion and ready for final inspection by the Texas Commission of Jails Standards.

HEAR & DISCUSS:

----- County Auditor-Jimmy Hamilton advised the Court that the county has already received 91% of the ad valorem taxes expected for the current fiscal year. The Court also discussed voting locations for the March 10, 1998 Primary Election.
