Regular Session Commissioners Court October 12, 1998

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as changed-Judge Bobbitt read aloud #7026 listing the 8 re-sale properties, buyers and amounts not previously presented to the Court; also adding 3 additional employees to the Sick Time Bonuses for 1998.

NEW BUSINESS:

7030 On the motion by Judge Bobbitt, second by Allen Martin, the Court approved renewal of the Hunt County Investment Policy & Investment Strategies for annual review in accordance with the public funds investment act as presented to the Court by Louise Walker-Hunt County Treasurer.

103/ On the motion by Judge Bobbitt_e second by Martin, the Court approved amendment to the Tax Abatement Agreement for Circuit Automation located in Commerce concerning eligible property-the language has been modified which did not expand actual property, only the equipment within the property.

7032 On the motion by Ralph Green, second by Martin, the Court approved the final plat for the Meadow View Acres in the James McAdams survey (133.229 acres) in Pct 2 with the following stipulations-since the developer Mike Moore did not have the correct ROW on the road, Commissioner Green is requiring a test on the road showing the compaction on the sub-base, base & thickness of the rock on the base to be done. *Final acceptance of completed road would be 1 year after completion date of the entire road.

7033 On the motion by Green, second by Kenneth Thornton, the Court approved the final plat for the Southfork subdivision containing 113-2 ac lots in the Shelby County School Land survey in Pct 2 submitted to the court by developer Bob Sandlin. All utility letters have been received. *Mylars to be corrected & sent to the Commissioners office for signatures.
7034 On the motion by Jim Walker, second by Thornton, the Court approved request from GTE Telephone Operations to bury cable along ROW of CR3602 in Pct 3 with the usual stipulations.

7035 'Possibly take action on bids for 1 or more truck tractors for Pct 2:' The Court received 1 bid from Southwest International Trucks for a 1999 4900 4 x2 meeting specifications for \$ 39,590, with the following trade-in 1991 GMC truck/tractor Model 7000 \$6500 trade-in 1998 chevy truck/tractor cab/chassis 2250

On the motion by Green, second by Thornton, the Court accepted the bid & the trade-in offer. Bid accepted for 2 new trucks.

103 On the motion by Judge Bobbitt, second by Martin, the Court approved proclamation making Otober 11-17, 1998 as National & Texas Family Community Education Week in Hunt County as presented by Mary White and Bertha Brashears.
