

Regular Session
Commissioners Court
October 26, 1998

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:

7039 On the motion by Kenneth Thornton, second by Allen Martin, the Court adopted the following holiday schedule for 1999:

7040 On the motion by Judge Bobbitt, second by Martin, the Court approved the resolution dedicating the month of November as County-Wide Shared Ministries Awareness Month.

7041 On the motion by Judge Bobbitt, second by Ralph Green, the Court approved the resolution to make February 19th- State of Texas Anniversary Remembrance (S.T.A.R.R.) Day as a special day each year to observe the birthday of the State of Texas and to celebrate the rich and diverse heritage of the people of the State of Texas.

7042 On the motion by Green, second by Thornton, the Court approved the Final plat for Caddo Creek Subdivision in Pct 2 presented in court by Nicholas Feldman. *Note Lot 15-changes were made to the size of lot to allow space required for septic system.

7043 On the motion by Jim Walker, second by Martin, the Court approved the Final plat for the North Shores Acres Subdivision, a .20 acre plat with 10-2 acre lots located in Pct 3. Developer Jimmy Seay presented the plat to the court stating it has been approved by the Lake Tawakoni Planning Association.

7044 On the motion by Walker, second by Martin, the Court approved acceptance of Ranchwood Street and Ranchwood Circle located in Ranchwood Estates Subdivision to county maintenance. Mr. Dale was present stating the compaction test has been done (2 1/2'-2' on 3600').

7045 On the motion by Judge Bobbitt, second by Green, the Court approved appointment of Gene Bledsoe M.S. as board member to Northstar. This volunteer position is for a 1 year appointment.

7046 On the motion by Green, second by Thornton, the Court approved the quarterly investment report for July 1 thru September 1, 1998 which was presented by Louise Walker-County Treasurer who stated our TxPool average was 5.56% on monies invested.

7047 On the motion by Martin, second by Green, the Court approved a 1 year contract with ACG Advanced Communications. Representative P.K. Gray advised the court that all local services would come to Hunt County on one bill, whether our current bill is from SWB, GTE or Sprint United, which would allow a simple breakdown of costs and a one point of contact for service for everyone. This would allow a savings of \$132 per month for the county, also allowing all long distance calls at 10¢ per minute on stationary lines-no cellular phones. There is no penalty change over cost from SWB, ACG absorbs all costs.

— 'Discuss and possibly take action on submitted bid for property R81992:' After much discussion, the Court dropped item from the Agenda to allow proper posting.

7048 'Discuss and possibly take action on bids for Rock & Rock Hauling:' On the motion by Green, second by Thornton, the Court accepted all bids received on rock, except Meridian, Terrell, Tx. & Norton Crushing, Terrell, Tx. Bids on file in auditors office.
