

Regular Session
Commissioners Court
November 9, 1998

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as submitted.

NEW BUSINESS:

7055 On the motion by Ralph Green, second by Kenneth Thornton, the Court accepted bids on pre-mixed oil & sand from the following: Buster Paving-Greenville, Tx. \$24 per ton delivered
\$22 per ton at yard

Tyler Asphalt- Tyler, Tx. \$24.50 per ton delivered
\$18.50 per ton at yard

Bids on file in Auditors office.

7056 On the motion by Judge Bobbitt, second by Allen Martin, the Court approved the Tax Assessor-Collectors Annual Report. Joyce Barrow stated to the court 1997-98 was a record collection year.

7057 On the motion by Green, second by Martin, the Court approved the \$3,000 bid for property R81978 from Paula Gail Wilson which will alleviate right of way issues in the future.

'Discuss & possibly take action on update on CR3115:' Mike Bailey was present in court to discuss CR3115 off FM 1737, asking the Court if there are any improvement plans to return this 9/10's of a mile of road to its previous surface. Following discussion, Commissioner Walker stated as soon as his schedule and his budget will allow, then the roads will be repaired to what is was in 1996, which was an oil surfaced road.

7058 On the motion by Green, second by Jim Walker, the Court approved the final plat for Caddo Airport Evergreen Estates on FM 1565 in Pct 2, contingent upon the fees being paid to the County Health Department. Commissioner Green re-instated the requirement for 2 acre lots on plats.

7059 On the motion by Martin, second by Thornton, the Court approved the final plat for Nathan Green Subdivision in Pct 2 located in the Uriah Blue Survey (44.805 acres) having 15 lots. All utility letters have been received. (Commissioner Green abstained from the vote).

'Discuss & possibly take action on canvass of results from the November 3rd-General Election:' Linda Brooks-County Clerk stated to the Court that Hunt County has received a ballot which meets all necessary requirements to be counted as a "Late Ballot" due to new state statute. Official canvass will be set for November 10th at 10:00am with Commissioner Martin presiding.

'Discuss & possibly take action on CR 3128:' Harold Williams was present in court to discuss the condition of his road. Following discussion, Judge Bobbitt stated county policy is passed & approved by the Commissioners Court but the final decision for the maintenance of the county roads still belongs with the Commissioner. Also during the budgetary process this year changes were made according to the life structures in the precincts which will allow more maintenance money for Pct 2 & 3 than Pct 1 & 4, thus allowing for more improvements to the roads.

There was no HEAR & DISCUSS REPORTS.

7060 On the motion by Martin, second by Thornton, the Court approved accounts payable.
