

Regular Session
Commissioners Court
December 28, 1998

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

OLD BUSINESS:

7088 On the motion by Kenneth Thornton, second by Allen Martin, the Court approved the bid on copy & computer paper which was received by Pollock Paper.

NEW BUSINESS:

7089 On the motion by Ralph Green, second by Martin, the Court approved a resolution regarding Juvenile Accountability Incentive Block Grant of \$31,580 which will be used to enhance the community service program and possibly purchase a van. *Any match funding to come out of the Juvenile budget.

7090 On the motion by Judge Bobbitt, second by Jim Walker, the Court approved the resolution regarding the TxPool Bank Pledge Sheets & Federal Reserve Bank Pledge Authorization which transfers authority to County Treasurer elect Delores Shelton.

7091 On the motion by Green, second by Thornton, the Court approved the preliminary plat for High Hollows Phase 5 Sec A in Pct 2 which has 3 lots in the E P Lux survey containing 7.941 acres.

7092 On the motion by Green, second by Thornton, the Court approved the proposal for the financing of a motorgrader for Pct 2 from Alliance Bank for \$125,000 at 4.85% for 36 months (no administrative fees) for \$9,562.96. Also received were bids from American National Bank Leasing Co. & Bank 1--bids on file in the County Auditors office.

7093 On the motion by Walker, second by Martin, the Court approved the request of Greeville Electric Utility system for the ROW down Oakwood Rd., located in Ranchwood Estates subdivision, with the usual stipulations.

7094 On the motion by Martin, second by Walker, the Court approved the estimate of \$80,000 (plus or minus 5%) received from Southern Steel to repair 11 security doors in our county jail. Funds to be taken out of contingency fund due to the emergency nature of the matter. Also present in court was Noble Walker-Asst. District Attorney advising the court of the nine upcoming murder cases, 5 of which are capital murder cases, possibly requiring court appointed attorneys and interpreters. *(\$10,000 to come out of Jail Equipment Fund-Sheriff's Office & remainder \$70,000 to come out of contingency fund.)

7095 On the motion by Martin, second by Thornton, the Court approved accounts payable.

7096 On the motion by Green, second by Martin, the Court approved line-item budget transfers.
