COMMISSIONERS COURT  
MAY 24, 1999

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

OLD BUSINESS:

7228 On the motion by Kenneth Thornton, second by Ralph Green, the Court appointed Sarah Swindell to the Hunt County Child Protective Services Board.

NEW BUSINESS:

7229 On the motion by Thornton, second by Allen Martin, the Court approved the request from SWB Telephone to bury utility line along ROW of CR 1013 & 1014 in Pct 1 with the usual stipulations.

7230 On the motion by Jim Walker, second by Green, the Court approved the final plat for Hickory Lake Estates in Pct 3. Ernest Upchurch stated all fees have been paid & utility letters have been received.
