Currently, they receive \$2,496 annually from Hunt County, employ one person at minimum wage & they are looking for a larger location. They have operating expenses for utilities, salary and insurance on the building. All projects and materials are paid for out of their own pockets, its getting more difficult to raise funds. No action taken at this time.

HEAR & DISCUSS REPORTS:

Sharon Lindsey & Dawn Palen were present in court to discuss the condition of CR 2260, an oil road which is not drive able (they have even had to call a wrecker several times to be pulled from the ditch) asking the Court for rock and gradin to be done. Commissioner Walker stated this is bottom land, parts of the road are under water when it rains. He has put rock on this road and has done grading on culverts. Acting Judge Green advised these ladies that they must work with thei Commissioner; Commissioner Walker agreed to look at the road.

_County Auditor-Jimmy Hamilton reported to the Court that the first electric bill from Tx Electric in the amount of \$334.50 for the new facility housing the sub-station for the tax office and the J.P. Office in Quinlan has been received. Since the Tax Office does not have a line-item for utilities and the J.P.'s Office does, plus the utility company will not break down fees for these two offices, the court may need to create a new line-item for this purpose.
