

Regular Session  
Commissioners Court  
August 9, 1999

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

OLD BUSINESS:

- 7294 On the motion by Allen Martin, second by Kenneth Thornton, the Court accepted and approved the only bid received which was submitted by Yoder Construction for clear span bridges for all precincts. Bid on file in the Personnel Office.
- 7295 On the motion by Thornton, second by Ralph Green, the Court acknowledged notification from SWB Telephone on installation of communication cable along CR 1079, 1072 & 1073 in Pct 1, with the usual stipulations. Commissioner Thornton is still requesting proper location prints for his records.

NEW BUSINESS:

- 7296 On the motion by Green, second by Walker, the Court approved payroll changes which will schedule payroll checks to be issued every other Friday, with an effective starting date of October 15, 1999 for our new budget year.
- 7297 On the motion by Martin, second by Thornton, the Court approved the renewal of Health Care Insurance Programs with Blue Cross/Blue Shield with the Texas Association of Counties, which already reflects (5% increase) in our new FY 1999-2000 budget.
- 7298 On the motion by Green, second by Judge Bobbitt, the Court approved implimentation of the Hunt County Salary Plan and guideline rules at this time. This plan is to give veteran employees an incentive and employers flexabilty. Elected Officials will now be allowed to hire any new employees at a lower rate than an R-1 salary (\$17,897) which will allow extra monies for experienced-conscientious employees who have been hired longer to receive extra pay. The Court is to re-evaluate plan next year. For: Green, Bobbitt, Thornton, Martin. Opposed: Walker. Motion carries.
- 7299 On the motion by Green, second by Thornton, the Court approved implimentation date of August 16, 1999 for our salary plan. For: Green, Thornton, Martin. Abstained: Walker. Motion Carries.
- 7300 On the motion by Green, second by Martin, the Court approved the final plat for Stone Creek phase 1 in Pct 2. Michael Heine stated utility letters have been received.
- 7301 On the motion by Green, second by Thornton, the Court approved application for road upgrading on the following county roads:

- 7303 On the motion by Martin, second by Thornton, the Court approved an Air Quality Resolution involving Henderson, Hood, Hunt, Johnson, Kaufman, Parker & Rockwall Counties, which are part of the CSMA (Consolidated Statistical Metropolitan Area) who want to do their fair share of emission reductions to assist the Dallas/Ft. Worth area in achieving attainment of federal ozone standards. Hunt County also agrees to have air quality monitors located within the corporate boundary at the discretion of the TNRCC & the EPA.
- 7304 On the motion by Walker, second by Thornton, the Court approved the standard 2000 contracts for public health service between the Tx Department of Health, Hunt County & the City of Greenville, allowing for grant monies for certain employees
- \_\_\_\_\_ 'Discuss & possibly take action on any items pertaining to the new county jail:' Randolph Gheen, Construction Manager was present advising the court of the completion of dirt work, drilling of piers to start on Thursday & will present the court a detailed work schedule next court meeting.
- 7305 On the motion by Martin, second by Walker, the Court approved road upgrading from rock to oil sand on CR 4415, 4518, 4207, 4224, 4124, 4206, 4722, 4704 & dirt to rock on CR 4604 in Pct 4. Commissioner Martin stated some of the work is paid for by property owners & some is not.
- 7306 On the motion by Green, second by Thornton, the Court approved the final plat for Magnolia Place in Pct 2, contingent upon correction to the mylars to allow space for each Commissioner to sign for their approval of plat.
- \_\_\_\_\_ The court recessed at 10:45am, the court reconvened at 11:15am.
- 7307 On the motion by Martin, second by Green, the Court approved accounts payable. \*Judge Bobbitt abstained from the vote
- 7308 On the motion by Green, seconded by Thornton, the Court approved line-item budget transfers.

Sheriff: Remove Ashley Simpson as partime-she will be going to college. Please send her check & W-2 form to the address she has given you. Effective date 8-6-99.


Tax Office: Add Toni L. Hunter as partime clerk at \$6 per hour, effective 8-2-99.
