Regular Session Commissioners Court September 27, 1999

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

## OLD BUSINESS:

735/ On the motion by Ralph Green, second by Allen Martin, the Court approved the request for personnel re-alignment by Duncan Thomas-District Attorney to allow an additional investigator by transferring one secretary into that position with no additional funding from the County; will utilize state supplement & seizure money to fund position. This will also allow more effective court procedures.

## NEW BUSINESS:

- 7352 On the motion by Jim Walker, second by Green, the Court approved preliminary plat for Pine-View Estates in Pct 3 as presented by Frank Owens representing the developer.
