JANUARY 10, 2000

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:


- 7476 'Discuss and possibly take action on request for the extension on the preliminary plat for Water's Edge in Pct 3:'
Joe King advised the Court that they are still working on this development-No action by the Court.
- 7476 On the motion by Jim Walker, second by Allen Martin, the Court approved the request from GTE to place a buried telephone cable along the ROW of CR 3307, 3519 & 3520 in Pct 3 with the usual stipulations.
- 'Discuss and possibly take action on the Census 2000 Complete Count Proclamation:' Dr. Gary Bottoms explained to the Court how the next Decennial Census will be taken in the year 2000; how political representation to the U.S House of Representatives, State Legislatures & Local Governments is determined by this Census. By the formation of a Complete Count Committee which will include several sub-committees made up of Government, Education, Media, Religious, Community Based Organizations, Business Recruiting and Special Housing to help Hunt County get an accurate count of all its citizens and will re-draw boundary lines for congressional, representatives and school district lines. April 1, 2000 has been set as "Census Day."
- 'Discuss and possibly take action on considering acceptance of judgement bid property R 31604 for the amount of \$1,458.03 by Richard Miller:' Item dropped from the Agenda.
- 7477 On the motion by Kenneth Thornton, second by Martin, the Court approved acceptance of the judgement bid of \$1,548.03 on property R 31604 by Richard M. Miller.
- 7478 On the motion by Ralph Green, second by Walker, the Court approved engagement of an outside audit proposal submitted by Scott, Singleton & Fincher for the amount of \$18,000. For: Green, Walker, Bobbitt, Martin. Opposed: Thornton. Motion passes.
- 7479 On the motion by Judge Bobbitt, second by Martin, the Court approved moving the Law Library to the J.T.P.A. Office on the 4th Floor in order to create an office for the 354th District Court Reporter, storage room for the District Clerk, 196th District Court & 354th District Court. After the Court has consulted with the Historical Commission it will take under consideration closing up the hallway space between the County Attorney & Law Library for additional space for the County Attorney.
- 'Discuss any items pertaining to the New County Jail:' Matt Muliken stated work is now being done on the tilt panels and dirt work being done at the location of the old Bail Bond Building. Suggestion was made to go ahead and bid on the it not already bid on such as floor covering, fire extinguishers, equipment, etc.
- The Court recessed at 11:25am; went into Executive Session at 11:28am & reconvened at 11:47am returned to Regular Session
- 7480 On the motion by Martin, second by Walker, the Court approved accounts payable. Judge Bobbitt abstained from the vote
- 7481 On the motion by Green, second by Thornton, the Court approved line-item budget transfers.
