

COMMISSIONERS COURT
REGULAR SESSION
FEBRUARY 28, 2000

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:

- 7520** On the motion by Judge Bobbitt, second by Ralph Green, the court authorized an extended settlement agreement of up to \$500, which falls within the statute, concerning the tax seizure foreclosure suit between 3 S I Corp. VS Hunt County contingent upon the proper structure of documentation being prepared by our County Attorney-Peter Morgan. Judge Bobbitt is to sign for the Court. Hunt County will be released through this settlement.
- 7521** On the motion by Allen Martin, second by Kenneth Thornton, the Court approved the request of Duncan Thomas-District Atty. to allocate \$10,000 of officer seized automobiles & drug seizure money of forfeited funds, which the District Atty. by law gets a percentage of, to purchase computer equipment for \$7,000 and \$3,000 for training & schools. This approval does not require an amendment to the present budget.
- 7522** On the motion by Thornton, second by Martin, the Court approved the preliminary plat for Seville Estates in Pct 3. For: Thornton, Martin, Walker. Abstained: Green. Motion passes.
- 7523** On the motion by Thornton, second by Green, the Court approved the amended request of Bland ISD & Hurst Brothers Co., Inc. to change the route of buried utility cable line within the ROW of CR 1116, 1118, 1119, 1121 & 1123 in Pct 1 with the usual stipulations.
- 'Discuss & possibly take action on the sale of a used 16' X 40' steel bridge in Pct 4:' No bids received-Item dropped from the Agenda.
- 7524** On the motion by Walker, second by Martin, the Court approved enforcement on zoning violations in the Kitsee Knowll Estates of Lake Tawakoni by having the County Atty. proceed with civil action due to a Heating /Air Conditioning business operating in this area.
- The Court recessed at 10:30am; Court reconvened at 10:40am.
- 'Discuss & possibly take action on Poison Prevention Week Proclamation:' Item placed on OLD BUSINESS next court.
- 'Discuss & possibly take action on any items pertaining to the new county jail:' Judge Bobbitt stated workers are continuing to pour concrete, colors for sample panels have been picked & installation of windows to panels have been done to show the finished product. Judge Bobbitt also stated engineers from Kinsey/Sabine will come to look at the wall panels.
- 7525** On the motion by Green, second by Walker, the Court approved the EPA Air Quality resolution which will show where Hunt County stands and will get us to the negotiation stages of air quality control. Mark Rice was also present to discuss this matter with the court.
- 7526** On the motion by Martin, second by Walker, the Court approved accounts payable. Judge Bobbitt abstained from the vote.
- 7527** On the motion by Green, second by Thornton, the Court approved line-item budget transfers.


Maintenance: Add Craig Hudson as hourly worker at \$7.75 per hour, effective 2-28-00.
Add \$25 a month to David Simpson-hourly Maintenance Tech I, Grade 3, effective 2-28-00.


Sheriff: Remove John Johnston due to the requested resignation by Lt. Sneed, effective 2-21-00.


COMMISSIONERS COURT
