

COMMISSIONERS COURT
REGULAR SESSION
MARCH 13, 2000

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

OLD BUSINESS:

7531 On the motion by Allen Martin, second by Kenneth Thornton, the Court approved the week of March 19-25, 2000 as Poison Prevention Week in Hunt County.

NEW BUSINESS:

Discuss and possibly take action on establishment of a public library in Lone Oak, Tx.: Pamela Bedingfield was present to discuss this issue with the Court. Agreement was made by the court to help with funds available in this budget year after all the paperwork & filing is completed on the 501 C-3 for Non-Profit Charitable Organizations.

Discuss & possibly take action on services rendered through the Committee on Aging for the year 1999-2000: Sally Chavarria was present to give their monthly service report for fiscal year 101-99 thru 9-30-00.

7532 On the motion by Jim Walker, second by Martin, the Court approved request of SWB to bury utility line within the ROW of CR 3121 in Pct 3 with the usual stipulations.

7533 On the motion by Walker, second by Martin, the Court approved the request of GTE to bury utility line within the ROW of CR 3605 in Pct 3 with the usual stipulations.

7534 On the motion by Green, second by Thornton, the Court approved the request of SWB to bury utility line within the ROW of CR 2592 in Pct 2 with the usual stipulations.

7536 On the motion by Green, second by Walker, the Court approved the final plat on Country View Estates in Pct 2. For: Thornton, Walker, Martin. Abstained: Green. Motion passes.

7537 On the motion by Martin, second by Walker, the Court approved the bid for 20', 30' & 40' clear span bridges, all pcts to Yoder Construction. Bid on file in the Personnel Office.

7538 On the motion by Walker, second by Martin, the Court approved the bid for the sale of a used 16' X 40' steel bridge in Pct 3 to Ken's Tire Service in Lone Oak, Tx. All bids on file in the Personnel Office.

7539 On the motion by Martin, second by Walker, the Court approved the bid from Davis Construction for sale of a used house located at 1005 North Bois d'Arc Street in Commerce, Texas for the amount of \$1,755.00.

7540 On the motion by Green, second by Martin, the Court approved the bids from Yoder Construction on box culverts, all precincts.

7541 On the motion by Judge Bobbitt, second by Green, the Court accepted the following bids for the new county jail: sprayed fireproofing, carpet, vinyl & base, access flooring, metal lockers, laboratory equipment, fixed seating, testing and balancing. Furthermore, the court rejected bids on ornamental fencing & ceramic tile--to re-submit bid.

7542 On the motion by Martin, second by Walker, the Court approved the request of United Telephone of Texas to bury cable along the ROW of CR 4810 in Pct 4 with the usual stipulations.

7543 On the motion by Martin, second by Walker, the Court approved accounts payable. Judge Bobbitt abstained from the vote. There were no line-item budget transfers.

7544 Approved on the motion by Green, second by Martin.


Addendum:
