

COMMISSIONERS COURT
REGULAR SESSION
JUNE 12, 2000

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

NEW BUSINESS:

- 7611 On the motion by Jim Walker, second by Ralph Green, the Court approved the request to place a portable food storage building on Hunt county property located on Pickett Street for the storage of donated dry & canned foods for the "Say No To Drugs Campaign".
- 7612 On the motion by Allen Martin, second by Walker, the Court approved the May 2000 reports from the following Volunteer Fire Depts: Caddo Mills, Commerce, Lone Oak, Campbell, Merit & Wolfe City.
