

COMMISSIONERS COURT  
REGULAR SESSION  
JUNE 26, 2000

The Hunt County Commissioners Court met this day with all Commissioners present with Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented.

OLD BUSINESS:

7634 On the motion by Kenneth Thornton,, the Court approved the following new "Salary Committee" members:

NEW BUSINESS:

7635 On the motion by Ralph Green, second by Kenneth Thornton, the Court approved a resolution in support of application to seek approval to update & revitalize the Lakes Trail Region under the Texas Trails Region Program being offered through the Texas Historical Commission presented by Judy Woods.

7636 On the motion by Green, second by Martin, the Court approved leasing an RPS workstation from TxDot due to the increase in motor vehicle registration. This workstation will be used primarily to work with dealers & to do the mail on new cars only. Budgetary authority (\$1,500 a year) will be available thru the Mtr. Vehicle Insurance Verification Fund.

7637 On the motion by Jim Walker, second by Martin, the Court approved the order regarding the State adoption of food establishments including food service establishments, retail food stores, mobile food units & roadside food vendors. Although the fees have not been affected, grading procedures have been changed.

7638 On the motion by Martin, second by Walker, the Court approved the request of Sprint Telephone of Texas to install a buried communication cable along the ROW of CR 4428 in Pct 4 with the usual stipulations.

7639 On the motion by Green, second by Thornton, the court approved the request of FEC to construct an electrical power distribution facilities along & across CR 2400 in Pct 2 with the usual stipulations.

7640 On the motion by Walker, second by Green, the Court approved the request of FEC to construct electrical power distribution facilities along & across CR 3200 & CR 3613 in Pct 3 with the usual stipulations.

7641 On the motion by Walker, second by Green, the Court approved the final plat for North Shores Acres II in Pct 3 presented by Billy Green & Jimmy Seay.

7642 On the motion by Green, second by Walker, the Court approved action on the North Central Council of Governments Public Works Program, which is part of the Mass Transit Program, seeking funding for fiscal year 2001. According to our current population estimated at 74,500, our cost share will be approximately \$500.

7643 On the motion by Martin, second by Walker, the Court approved for the City of Campbell to piggyback off to Hunt County for cost of road materials for the next 3 years effective June 26, 2000 through June 26, 2003. This process is already being done with Collin County.

7644 On the motion by Green, second by Martin, the Court made a verbal agreement to authorize Judge Bobbitt to hire outside council, either Allison/Bass or Biggerstaff/Heath, which will get us on a list, for the redistricting 2000. The cost are estimated at approximately \$30,000 to \$40,000 which will be in next years budget. Proposal to be brought back to court for approval.

———— 'Discuss & possibly take action on any items pertaining to the new county jail:' Judge Bobbitt stated there would be a walk-through of the jail site tomorrow at 1:00pm.

7645 On the motion by Martin, second by Thornton, the Court approved accounts payable. Judge Bobbitt abstained from the vote.

7646 On the motion by Green, second by Martin, the Court approved line item budget transfers.

———— W.M. Brown was present to discuss the problem with the culvert on CR 3614, this road has flooded twice causing a problem with his buildings flooding, with the water escaping to Hwy 751. The ditches need to be cleaned out, someone left an old culvert which is holding back the water and it needs to be removed.

———— Judge Bobbitt also discuss information received from TxDot concerning the upcoming widening & expansion on Hwy 276 to come out of next years budget with the county responsible for 10% of the total costs.

\_\_\_\_\_ Commissioner Green stated he had received information today from Texas Assoc. of Counties concerning the Storm Water Coalition Regulations. Commissioner Green suggested that the County needs to get involved with this group, since they are involved with the Congress, TNRCC & the EPA, this would be a good investment for our Hunt County. Estimated costs would be according to our county's size. Agreement was made to place as an Agenda item next court for further discussion.

\_\_\_\_\_ Judge Bobbitt advised the Court of the Audie Murphy Days held this past weekend at the American Cotton Museum. There were approximately 300 visitors from as far away as Australia, New Jersey, England & Washington on the first day. An Apache Helicopter was here from Ft. Hood, with participation from Ft. Benning, Ga., Ft. Sill, Oklahoma and Ft. Hood, Texas. In simple donations the Committee received \$378; since March the Committee has collected from individual donations over \$6,000 which is to be used for the purchase of a bronze bust of Audie Murphy to be displayed in the Hunt County Courthouse, since it is our privilege to have the most decorated american military soldier in the history of the United States.




