July 24, 2000

The HUNt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved with change added on bid # 7662.

NEW BUSINESS:


- 7669** On the motion by Kenneth Thornton, second by Allen Martin, the Court agreed to approve releasing the Celeste Volunteer Fire Departments monthly stipend from Hunt County contingent upon the receipt of their report.
- 7670** 'Discuss & possibly take action on a request from the Campbell Volunteer Fire Dept. to use Hunt County Equipment for fire prevention:' Nathan Smith was present asking the Court for their continued support, due to the lack of rain, Hunt County is in the high risk range. Furthermore, in the next few weeks a possible burn ban may be necessary, if no rain is received.
- 7671** On the motion by Green, second by Thornton, the Court approved the Judges & Alternate Judges for the November 7th, 2000 General Election. For: Green, Thornton & Martin. Abstained: Walker.
- 7672** On the motion by Martin, second by Green, the Court approved the resolution from Kerbow & Associates promoting fair housing in Hunt County which will provide grant dollars for the County.
- 7673** On the motion by Martin, second by Green, the Court approved the resolution from Kerbow & Associates recognizing all applicable state & local laws regarding the use of excessive force during non-violent civil rights demonstration.
- 7674** On the motion by Green, second by Walker, the Court approved the 2001 contract for Public Health Services between the Texas Dept. of Health, Hunt County & the City of Greenville. Joe Lilly was not able to be present, but advised the Court this is the same contract we approved last year.
- 7675** On the motion by Martin, second by Walker, the Court approved an Environmental Health Service Agreement between the Hunt County Health Dept. & the Cities of Caddo Mills, Campbell, Celeste, Commerce, Hawk Cove, Lone Oak, Quinlan, West Tawakoni & Wolfe City for a Food Service Inspection & Licensing Agreement the same as last year, with no changes added.
- 7676** On the motion by Green, second by Martin, the Court ^{approved} the request of GTE to bury telephone cable along ROW of CR 2740, 2168, 2526 & 2620 in Pct 2. with the usual stipulations.
- 7677** On the motion by Thornton, second by Walker, the Court approved the request for road upgrade of dirt to rock on CR 1089 in Pct 1. Commissioner Thornton advised the Court an escrow on deposit of \$5 per foot has been received.
- 7678** On the motion by Green, second by Thornton, the Court approved the request of FEC to construct electrical distribution facilities along & across CR 2422 in Pct 2 with the usual stipulations.
- 7679** On the motion by Walker, second by Martin, the Court approved the request of FEC to construct electrical distribution facilities along & across CR 2628 in Pct 2 with the usual stipulations.






