

**COMMISSIONERS COURT**  
**REGULAR SESSION**  
*November 13, 2000*

The Hunt County Commissioners Court met this day at 10:00AM with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting on were approved with changes added to #7793, #7794, and #7795.

OLD BUSINESS:

**7800** On the motion by Ralph Green, second by Allen Martin, the Court accepted all bids received on rock / all bids originating from different location points. All bids on file in the Personnel Office.

NEW BUSINESS:

**7801** On the motion by Green, second by Martin, the Court approved a 32¢ mileage reimbursement for Hunt County (which is the same amount the state pays) for employees required to travel within the County and outside the County when not furnished a vehicle.

**7802** On the motion by Martin, second by Kenneth Thornton, the Court approved the following 2001 Holiday schedule for Hunt County:

**7803** On the motion by Jim Walker, second by Martin, the Court approved and accepted the preliminary 1<sup>st</sup> installment payment of (\$1,440.00) for the year 2000 Off-System Bridge Project for the Caney Creek Bridge located on CR 3111. The total estimated cost to the County for this bridge is \$14,400.00 with the awarding of this construction projected in May of 2001.

**7804** On the motion by Green, second by Thornton, the Court approved the request of Verizon Communication to place a buried telephone cable along ROW of CR 2740 in Pct. 2 with the usual stipulations.

**7805** On the motion by Martin, second by Walker, the Court approved request of Sprint Telephone of Texas to place a buried telephone cable along the ROW of CR 4509 in Pct. 4 with the usual stipulations.

**7806** On the motion by Martin, second by Walker, the Court approved the final plat for R. Grockett Estates in Pct. 4.

**7807** On the motion by Martin, second by Thornton, the Court accepted bids from Aramark and Unifirst for evaluation. Bids on file in Personnel Office.

**7808** On the motion by Martin, second by Green, the Court approved the resolution for the County to participate in the State Travel Management Program through the General Services Commission to provide access to the states contract airline fares pursuant to T.G.C. 2171.055 (E) and 1 TAC, 125.3 (27), (29), 125.29. The Court noted that all airline tickets need to go through the Auditors Office.

**7809** On the motion by Walker, second by Thornton, the Court approved a \$250.00 sick time bonus to Henry Wilkerson for the budget year of 1999-2000, due to filing of time error in payroll debt.

**7810** On the motion by Thornton, second by Green, the Court approved the Canvass of the November 7<sup>th</sup> General Election as presented by County Clerk-Linda Brooks.

— ‘Discuss any items pertaining to the new county jail.’ There were no items to discuss, Judge Bobbitt stated to the Court that he had taken a walk through inspection this weekend and the jail is 99% water proofed.

**7811** On the motion by Martin, second by Thornton, the Court approved accounts payable. Judge Bobbitt abstained from the vote.

**7812** On the motion by Green, second by Walker, the Court approved line item budget transfers.



The Commissioners Court of Hunt County, Texas meeting in

the following resolution:

WHEREAS, the State of Texas, General Services Commission (GSC) is authorized to provide access to the State's contract airline fares pursuant to Texas Government Code § 2171.055 (e), and 1 TAC, § 125.3 (27), (29), 125.29; and

WHEREAS, the Commissioners Court of Hunt County authorizes the county and its officers or employees or persons who are in the custody of the state, to participate in the program established by the GSC to gain access to the State's contract airline fares; and

WHEREAS, the county will abide by all rules, policies and procedures established by the GSC for participation in the State's contract airline fare program; and

WHEREAS, the county acknowledges its obligation to pay an annual participation fee based on county population as established annually by the GSC; and

NOW, THEREFORE BE IT RESOLVED, by the Commissioners Court of the County of Hunt, Texas, that request be made to the GSC to approve this County for participation in the program for the purpose of obtaining the State's contract airline fares.
