

COMMISSIONERS COURT
REGULAR SESSION
November 27, 2000

The Hunt County Commissioners Court met this day at 10:00AM with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting on were approved as presented.

OLD BUSINESS:

7814 On the motion by Kenneth Thornton, second by Ralph Green, the Court approved bid for three a year contract renewable each year from Aramark for Uniform Rental. For: Thornton, Green and Bobbitt. Abstained-Walker. Opposed-Martin. Motion passes.

7815 On the motion by Allen Martin, second by Thornton, the Court approved the correction on the Holiday schedule for 2001 making Martin Luther King day on Monday January 15, 2001.

NEW BUSINESS:

7816 On the motion by Martin, second by Jim Walker, the Court approved the County Fire Incident Report for October presented to the Court by Dorsey Driggers. This is a combined report from all volunteer fire departments. The Court agreed that Hunt County gets a high level of performance for the money we donate.

7817 On the motion by Green, second by Martin, the Court approved the request of Verizon Wireless Communications to place a buried telephone cable along the ROW of CR 2537 in Pct 2 with the usual stipulations.

7818 On the motion by Green, second by Thornton, the Court approved the request of FEC to construct electrical power distribution facilities along and across CR 2444 in Pct. 2 with the usual stipulations.

7819 On the motion by Thornton, second by Green, the Court approved a 900' road upgrade of dirt to rock for CR 1114 in Pct. 1. Money has been deposited in escrow.

7820 On the motion by Martin, second by Walker, the Court approved the request of FEC to construct electrical power distribution facilities along and across CR 4116 and 4705 in Pct. 4 with the usual stipulations.

— ‘Discuss and possibly take action on election dates for the City Incorporation for the City of Mt. Bethel.’ Item dropped from the Agenda due to the application incomplete at this time. Judge Bobbitt stated there will be a hearing set for Thursday evening.

— ‘Discuss and possibly take action on request for Hunt County to file a step application on behalf of the Campbell WSC for the construction of water system improvements.’ David Beard with Hayter Engineering was present to discuss the possibility of Campbell WSC receiving grant money of \$350,000 (originally to go to Hickory Creek WSC) due to Hickory Creek WSC dropping out. Hunt County would act as a pass through entity, with no cost to the County. The Court agreed to place this item on Old Business to allow time to receive a certified copy of a rejection letter of the Hickory Creek minutes.

7821 On the motion by Green, second by Walker, the court accepted both bids for premixed oil and sand from Tyler Asphalt and Buster Paving. All bids on file in the Personnel Office.

7822 On the motion by Martin, second by Green, the Court approved policy for County employees to be issued ID cards and badges. It will be up to each elected official to make the final determination for wearing the badges. ID cards to have full name of each employee; badges will only have first name and office of employment.

— ‘Discuss any items pertaining to the new County Jail.’ No items to discuss.

— On the motion by Judge Bobbitt, second by Thornton, the Court made the presentation of safety awards to all Commissioners and one for the Maintenance Department for no bodily accidents for the year 1999-2000.

7823 On the motion by Martin, second by Walker, the Court approved accounts payable. Judge Bobbitt abstained from the vote. The Court made note of payment of \$180.00 (\$60 per attorney) to the District Attorney to permit participation in the local bar association membership.

— There were no line item budget transfers.


7824 Approved on the motion by Walker, second by Martin.
