

**COMMISSIONERS COURT
REGULAR SESSION**
January 8, 2001

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved with changes added.

OLD BUSINESS:

7853 On the motion by Ralph Green, second by Phillip Martin, the Court approved bid from Pollock Paper for copier and computer paper. Bid on file in the Personnel Office.

7854 On the motion by Allen Martin, second by Green, the Court approved support of step application program to pursue grant on behalf of the City of Campbell WSC for the construction of water system improvements. David Beard present in Court presented a step down cancellation participation from Hickory Creek WSC minutes of November 14, 2000, due to the County's sponsorship of only 1 step program each year. This program will be no cost to the County.

NEW BUSINESS:

7855 On the motion by Kenneth Thornton, second by Allen Martin, the Court approved the quarterly report from the Boys and Girls Club presented by Sonya Coker.

7856 On the motion by Green, second by Thornton, the Court approved the final plat for Branden Manor-Phase One with the understanding that culverts may need to be enlarged.

7857 On the motion by Green second by Allen Martin, the Court agreed for Aerie Networks to bore under CR's in Pct. 2.

7858 'Discuss and possibly take action to approve the placement of fiber optics cable along CR 1140 in Pct. 1.' After discussion Commissioner Thornton made suggestion to go down parallel with pipeline instead of CR ROW. Item dropped from Agenda.

7859 On the motion by Allen Martin, second by Phillip Martin, the Court approved request of Sprint to install buried cable along ROW of CR 4516 in Pct 4 with the usual stipulations.

7860 On the motion by Green, second by Thornton, the Court approved request of SWB to install a buried cable along the ROW of CR 2458 and 2469 in Pct. 2 with the usual stipulations.

7861 On the motion by Thornton, second by Allen Martin, the Court approved the request of SWB to install a buried cable along ROW of CR 1001, 1057, 1061, 1062 and 1116 in Pct. 1 with the usual stipulations.

7862 On the motion by Allen Martin, second by Green, the Court received 3 bids for the sale of a used 16'X35' steel bridge in Pct. 4 and approved the bid from Thornton Escavation for \$876.00. All bids on file in the Personnel Office.

Abstained: Thornton.

Motion passes.

7863 On the motion by Judge Bobbitt, second by Allen Martin, the Court approved raised flooring which was to be installed by ReSource Texas in the amount of \$15,200 and have agreed for Allied Interiors to take contract for the same amount. The Court further discussed that interior painting is in the finish out phase, an ornamental fence has been installed and the ceilings in the jail and detention area are completed.

HEAR AND DISCUSS REPORTS:

— The Court discussed Uniform Maintenance due to Commissioner Martin being dissatisfied with the service of Aramark. Commissioner Green stated his service has been good.

Also discussed were the special needs for training due to transition of new employees in the County Attorneys Office. Keith Willeford asked for transfer of money from employee's line item for training of employees within his current budget.

7864 On the motion by Allen Martin, second by Green, the Court approved accounts payable. Judge Bobbitt abstained from the vote.

— There were no line item budget transfers.


