### INDEMNITY AGREEMENT

Hunt County shall not be liable or responsible for, and shall be saved and held harmless by Aerie Networks, Inc. from and against any and all suits, actions, losses, damages, claims, or liability of any character, type, or description, including all expenses of litigation, court cost, and attorney's fees for injury or death to any person, or injury to any property, received or sustained by any person or persons or property, arising out of, or occasioned by, directly or indirectly, the performance of Aerie Networks, Inc. under this agreement, see attached Exhibit "A", including claims and damages arising in whole or in part from the negligence of Hunt County.

It is the expressed intent of the parties to this Agreement that the indemnity provided for in this section is an indemnity extended by Aerie Networks, Inc. to indemnify and protect Hunt County from the consequences of Hunt County's own negligence, Hunt County [whether that negligence is the sole or contributory cause of the resultant injury, death, or damage or provided, however, that the indemnity provided for in this section shall apply only when the negligent act of Hunt County is a contributory cause of the resultant injury, death, or damage, and shall have no application when the negligent act of Hunt County is the sole cause of the resultant injury, death, or damage, unmixed with the legal fault of another person or entity].

Aerie Networks, Inc. further agrees to defend, at its own expense, and on behalf of Hunt County and in the name of Hunt County, any claim or litigation brought in connection with any such injury, death or damage.
