

COMMISSIONERS COURT
REGULAR SESSION
June 25, 2001

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the pervious meeting were approved as submitted.

NEW BUSINESS:

— ‘Presentation of service award to Carl Massey in Pct. 1.’ Commissioner Kenneth Thornton presented a plaque for 17 years of service to Carl Massey-Equipment Operator due to his upcoming retirement June 29, 2001.

8013 On the motion by Kenneth Thornton, second by Allen Martin, the Court approved proclamation making June 22 thru June 30, 2001, as “Forget-Me-Not” Week in Hunt County for our Disabled American Veterans.

— ‘Discuss and possibly take action on quitclaim deed for property R52866: Joyce Barrow-Tax Assessor.’ The Court agreed to place on OLD BUSINESS next court to allow Ms. Barrow to be present for discussion on this matter.

8014 On the motion by Phillip Martin, second by Allen Martin, the Court approved the phone contract for 2 phones from Crumpton TV and Cellular, even though the County is currently under a State Phone Contract, we plan to transfer back to Crumpton TV and Cellular. The Court noted if the County Attorney’s statement exceeds \$49.00-he will be responsible for the additional fees.

8015 On the motion by Ralph Green, second by Allen Martin, the Court approved the InterLocal Agreement with the Texas Forest Service allowing them a temporary office in the new jail-they need an office for fast dispatch. In the future, Hunt County is scheduled to get a Regional office for the Forest Service. Agreement was made by the Court that they would provide their own equipment (telephones, expense of the phones and purchase of their own office furniture); Hunt County will provide the space.

8016 On the motion by Phillip Martin, second by Green, the Court approved the submission to the State Comptroller’s office request for unclaimed electric cooperative funds (\$4,900) per Sec. 74.602 TX Property Code.

8017 On the motion by Allen Martin, second by Phillip Martin, the Court approved request of North Hunt WSC for ROW easement on CR 4818 for new water lines in Pct. 4 with the usual stipulations.

— ‘Discuss and possibly take action on final plat for Quail Meadow Estate in Pct. 3.’ Commissioner Phillip Martin ask this item to be dropped from the Agenda-to be placed on next court meeting.

8018 On the motion by Green, second by Thornton, the Court approved request of FEC Electric to construct electrical power distribution facilities along and across CR 2580 and CR 2658 in Pct. 2 with the usual stipulations.

8019 On the motion by Phillip Martin, second by Allen Martin, the Court approved request of FEC Electric to construct electrical power distribution facilities along and across CR 3124, CR 3210, and CR 3605 in Pct. 3 with the usual stipulations.

8020 On the motion by Thornton, second by Allen Martin, the Court approved the preliminary and final plat for Greenville acres in Pct. 1. All fees have been paid.

8021 On the motion by Thornton, second by Phillip Martin, the Court agreed to place the Celeste Public Library funding on the county program. Doug Wehmeyer stated the library is currently opened in the summer with approximately 145 members with 2,500 books received through donations. Mr. Wehmeyer stated the 5013C papers have been received.

— ‘Open and possibly take action on bids for the sale of 2 used 12H Caterpillar Motor graders from Pct. 2.’ No bids received.

8024 On the motion by Allen Martin, second by Thornton, the Court approved line item budget transfers.



**Inter-Local Agreement
Texas Forest Service

This inter-local agreement (the "Agreement") between Hunt County, hereinafter called the CONTRACTOR and the TEXAS FOREST SERVICE, an agency of the State of Texas, hereinafter referred to as the SERVICE.

Authority: Texas Government Code Title 7, Chapter 791, Sub-Chapter A, Section 791.001. The purpose of this chapter is to increase the efficiency and effectiveness of local governments by authorizing them to contract, to the greatest possible extent with one another and with agencies of the state.

STATEMENT OF SERVICES TO BE PERFORMED:

CONTRACTOR will furnish temporary office space to the SERVICE in Greenville, Hunt County, Texas. There will be no charge for this space, electrical or janitorial service. The SERVICE shall pay for telecommunications installation into the office space and for all monthly telecommunications expenses for said office.

TERMS OF AGREEMENT:

This agreement is to begin on June 25, 2001 and shall have an open termination date, with no changes to the original agreement.

Either the CONTRACTOR or the SERVICE may terminate this agreement any time upon seven (7) days written notice to the other party prior to the termination of service. In the event of early termination, the SERVICE shall only be liable for payment of services performed to termination.

AMOUNT OF AGREEMENT

There will be no charge for this space, electrical or janitorial service. The SERVICE shall pay for telecommunications installation into the office space and for all monthly telecommunications expenses for said office.

GENERAL CONDITIONS

The parties will meet to negotiate resolution of problems or conflicts concerning interpretation or implementation of the terms of this agreement.

This agreement may be amended by written application from one party to the other and written concurrence by the responsible party.

THE UNDERSIGNED CONTRACTING PARTIES do hereby certify that, (1) the services specified above are necessary and essential for activities that are properly within the statutory functions and programs of the effected governmental entities, (2) the proposed arrangement serve the interest of efficient and economical administration of the State, and (3) the services, supplies or materials contracted for are not required by Section 21 of Article 16 of the Constitution of Texas to be supplied under contract given to the lowest responsible bidder.
