

COMMISSIONERS COURT
REGULAR SESSION
December 10, 2001

The Hunt County Commissioners Court met this day with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meetings held November 26, 2001 were approved as presented.

OLD BUSINESS:

8210 On the motion by Ralph Green, second by Kenneth Thornton, the Court approved low bid received from Chaney paper, located in Royse City for 2001-2003 for janitorial supplies. Trey Chaney was present in Court to discuss issue. All bids on file in the Personnel Office.

NEW BUSINESS:

8211 On the motion by Judge Bobbitt, second by Thornton, the Court approved the appointment of Phyllis Gipson as representative to the Hunt County Danas Board of Directors, due to Dr. Harry Fullwood stepping down.

8212 On the motion by Phillip Martin, second by Green, the Court approved the increase of the dollar amount to \$5,000 from \$1,000 for recording equipment as a fixed asset (retroactive to 10-01-2000) due to Gadsby 34. Tammie Byrd, present in Court for County Auditor – Jimmy Hamilton, stated their office would be using Peachtree Accounting for inventory items.

8213 On the motion by Phillip Martin, second by Thornton, the Court accepted Sundown Road (0.416 mile) in the Sundown Ranch Development into the County Maintenance System in Pct 3, effective this date December 10, 2001.

8214 On the motion by Allen Martin, second by Phillip Martin, the Court approved the final plat for Aberfoyle Estates in Pct 4 after receiving all affidavits from current property owners acknowledging county easement. For: Allen Martin, Phillip Martin and Thornton. Opposed Green. Motion passes.

— ‘Discuss and possibly take action on Blockdale Meadows Estates Phase II in Pct 2.’ Commissioner Green ask for this item to be placed on OLD BUSINESS for next court.

— ‘Discuss & possibly take action on “No Dumping” signs received from NTCOG for Environmental Enforcement.’ Mike Pierce was present to advise the Court of the signs received for Hunt County from NTCOG. This was a grant item from Cog for 16 counties

based on the population and rural areas. Hunt County also plans to give the City of Greenville 5 signs.

8215 On the motion by Allen Martin, second by Green, the Court approved repairs needed for the west elevator in the Courthouse. Judge Bobbitt stated the gear box (1929) needed to be fixed. Agreement was made by the Court, repair cost not to exceed \$25,000, additionally an itemized list will be given to the Court before final payment is made.

8216 On the motion by Green, second by Phillip Martin, the Court approved bid for Motor Grader in Pct 2 from Darr Equipment, a 140H Cat for \$165,797. Bid on file in the Personnel Office.

8217 On the motion by Thornton, second by Allen Martin, the Court approved the revision to the 2002 Holiday schedule by including Labor Day, September 2, 2002.

8218 On the motion by Green, second by Phillip Martin, the Court approved providing lunch Tuesday, December 11, 2001 for the Maintenance Personnel as a reward and thank you for their work done over the weekend on the New Justice Center due to the inspection Monday by the Jail Standards Commission. Judge Bobbitt stated he was very proud of the Maintenance Staff and the work accomplished by utilizing the jail trustees. Payment to be make from the Jail Fund.

8219 On the motion by Allen Martin, second by Green, the Court approved accounts payable.

— There were no line item budget transfers.


