The Hunt County Commissioners Court met this day at 10:00A.M. with all Commissioners present and Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as presented. The Court noted change in minutes of May 27, 2003 #8750.

— 'Discuss and possibly take action on acceptance of Griffin Communications system lease contract.' Item dropped from the agenda.

#### NEW BUSINESS:

**8775** On the motion by Kenneth Thornton, second by Ralph Green, the Court approved presentation made by Mary Sue Cole – Extension Dept. Certificates for Continuing Education hours from the V. G. Young Institute of County Government from a conference held February 18-22, 2003 to the County Judge and each member of the Court.

Hear and discuss greetings from Karl Keck, Kuwait, Iraq presented by Charles
Engle – Veterans Service Officer of Hunt County: 'Mr. Keck sent thanks to the
Commissioners Court for maintaining the Veterans Service Office. Furthermore, Mr.
Keck sent each Commissioner a personal message with a cap from Iraq.

— "Discuss and possibly take action on presentation requesting financial support for the Northeast Texas Children's Museum:" David Caldwell – Executive Director of the Museum was present to discuss this issue with the Court. Judge Bobbitt stated this request will be added into the budget process for FY 2003-2004 with workshops to begin the last two weeks of July. This is a great project, which benefits children not only in Hunt County, but also in surrounding counties. Mr. Caldwell requested a retired police car to be used as a display for the museum.

**8776** On the motion by Phillip Martin, second by Green, the Court approved a Resolution for an Interlocal Agreement for the Lakes MHMR Center. Commissioner Martin thanked the Court for working together on this issue. Judge Bobbitt advised the Court the State is still in full management of MHMR, while the Lakes are completing the day to day management tasks. Commissioner Court will appoint a representative for Hunt County this fall.

**8777** On the motion by Green, second by Thornton, the Court approved the final plat for South Gentry, Phase 2 in Pct 2 presented by Frank Owens. Escrow funds have been deposited for future road upgrades.

**8778** On the motion by Green, second by Thornton, the Court approved road upgrade of approximately 2,000 feet of rock to seal coat on CR2584 in Pct 2. Money deposited into Escrow.

— 'Discuss and possibly take action on preliminary plat for Black Oak Estates in Pct. 2: Clayton McGowan, Rodney Hetzel & Dub Dufray were present to discuss this subdivision located off Hwy 34 which will have its own sewer treatment plant with Cash Water Supply furnishing water for these 1,000 sq. ft. lots. Commissioner Green stated he felt there were traffic concerns due to having only (1) entrance on Hwy 34 and the exit road at the back of this subdivision has drainage problems and the road isn't wide enough, it will require 60 ft of ROW's to FM 1903. The Court agreed before the final plat is approved a solution for these traffic flow problems will have to be solved. Judge Bobbitt suggested these men work with Commissioner Green to find a possible solution to allow good circulation of the traffic.

8779 On the motion by Martin, second by Latham, the Court approved request of GEUS to construct electrical power distribution facilities along and across CR3311 and Oakwood Drive in Pct 3 with the usual stipulations.

8780 On the motion by Martin, second by Latham, the Court approved request of FEC Electric to construct electrical power distribution facilities along and across CR3602 in Pct 3 with the usual stipulations.

8781 On the motion by Judge Bobbitt, second by Martin, the Court approved the appointments of Judge Bobbitt, County Auditor Jimmy Hamilton, Diane Terry, Commissioner Latham and Marilyn Jacobs of Personnel Dept. to organize and develop a policy for purchasing through Co-ops. To be a new item next Commissioners Court.

8782 On the motion by Judge Bobbitt, second by Martin, the Court approved exemption from the bidding process the purchase of the Tax Office security equipment (including Quinlan sub station) (per L.G.C. 262.024 #2 – discretionary exemption dealing with necessity items).

**8783** On the motion by Martin, second by Latham, the Court approved the purchase and financing of security equipment for the Tax Office (including the Quinlan Sub Station). Mr. Griffin of Griffin Communications advised the Court cost would be \$30,495.50, including 1 year warranty, with Bank 1 financing of 4.45%. The maintenance agreement goes into effect April 2004.
