Present for this discussion were representatives from the Democratic and Republican parties, Charles Elliott from Texas A&M in Commerce, Richard Carter, Sherry Tice and Wymon Williams were present from the Hospital Board, Quinlan ISD, Bland ISD, Boles ISD, the City of Greenville, City of Commerce, City of Quinlan; also present was Honorable Patsy Cox – Harrison County Clerk and Pam Ellis – Harrison County Elections Administrator.

After much discussion, Judge Bobbitt ask each entity present if they would be in favor of an elections administrator, with receiving a positive response, the Court took a consensus vote to keep the elections administrator position in the Budget for FY 2003 – 2004.


