

COMMISSIONERS COURT
REGULAR SESSION
June 28, 2004

The Hunt County Commissioners Court met this day at 10:00A.M. with all Commissioners present with Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as submitted.

OLD BUSINESS:

9135 On the motion by Ralph Green, second by Kenneth Thornton, the Court approved the final plat for Henson Addition in Pct 2. Money has been deposited into Escrow account, with required road bond in place.

9136 On the motion by Green, second by Phillip Martin, the Court approved the final plat for The Oaks Addition in Pct 2.

NEW BUSINESS:

— ‘Discuss and possibly take action on validity of the City of Lone Oak Local Option Liquor Petition - Almina Cook.’ Two petitions were turned in, the first petition (April 6, 2004) was invalid due to lack of required signatures; the second petition was valid (June 8, 2004) receiving the required signatures. Election date to be set in 30 days. The Court agreed no action needed by Court. *See Attachment.*

9137 On the motion by Martin, second by Jim Latham, the Court approved proposal to publish (advertise for 3 bids) and accept bids to design, construct and install computer workstations, for the Hunt County Tax Office utilizing existing budgeted funds (to include Quinlan Sub – Station) for approximately \$15,000 to \$20,000. *See Attachment.*

9138 On the motion by Judge Bobbitt, second by Martin, the Court approved extended warranty for the 911 recorder system in the amount of \$4,220.22 (County to receive a 10% discount off this amount). Funding to be paid out of 10-020-6637. *See Attachment.*

— ‘Discuss and possibly take action on request to sponsor a 2005/2006 Texas Community Development Program Grant Application on behalf of Combined Consumers Special Utility District – Steve Kerbow.’ This project to take place in Hawk Cove area, funds to be dispersed thru the County Auditor and Treasurer. Agreement by the Court to place on OLD BUSINESS to discuss further.

9139 On the motion by Judge Bobbitt, second by Thornton, the Court approved road upgrade of approximately .930 miles of CR 2146 from dirt to rock in Pct 1. Money deposited into Escrow account.

9140 On the motion by Thornton, second by Martin, the Court approved road upgrade of dirt to rock on CR 2148, 2154, & 2152 in Pct 1. Money deposited into Escrow account. For: Thornton, Martin, & Latham. Against: None. Abstained: Ralph Green. Motion carries.

9141 On the motion by Thornton, second by Martin, the Court approved request of Cap Rock Energy to build a 14.4 kv power line inside the right of way of CR 1116 in Pct 1 with the usual stipulations.

9142 On the motion by Green, second by Latham, the Court approved final plat for High Hollows V, Section D in Pct 2 presented by Jerry Wisdom. The Court noted 2 additional lots (2.6 acres each) were approved.

9143 On the motion by Green, second by Thornton, the Court approved request of FEC Electric to grant permission to construct electrical power distribution facilities along and across CR 2472 in Pct 2 with the usual stipulations.

9144 On the motion by Martin, second by Green, the Court approved improvements to CR 3706 and 3707 in the amount of \$50,000 in Pct 3. Money deposited into Escrow account.

9145 On the motion by Martin, second by Green, the Court approved the final plat for Villages at Lone Oak - Phase 1, Village at Fox Hollow in Pct 3 presented by Rich Jennings. Plat approved with stipulation of maintaining a letter of credit until roads are built and approved by Commissioners Court, rather than a road bond due to the time element involved. The Court stipulated the letter of credit shall be attached to plat before filing. *See Attachment.*

9146 On the motion by Martin, second by Green, the Court approved replat of portion of existing plat The Vineyards and final plat for the remainder of lots for The Villages at Lone Oak - Phase II, The Vineyards in Pct 3 presented by Rich Jennings. The Court stipulated the letter of credit be maintained until roads are built and approved by

Commissioners Court rather than a road bond due to time element involved. The Court stipulated letter of credit shall be attached to plat before filing. *See Attachment.*

9147 On the motion by Latham, second by Martin, the Court approved acceptance into the county road maintenance program Wolf Trail, Mary Lane and Benton Lane in Benton Estates. Commissioner Latham stated these roads have been constructed and have been in use for over 1 year.

9148 On the motion by Green, second by Latham, the Court approved amendment to the Hunt County Road Policy prohibiting the construction of concrete or masonry mailbox structure on right of way of any county road due to the liability factor.

9149 On the motion by Martin, second by Green, the Court approved the yearly report from Mike Pierce – Hunt County Environmental Enforcement Officer. *See Attachment.*

9150 On the motion by Martin, second by Latham, the Court approved accounts payable. Judge Bobbitt abstained from the vote.

9151 On the motion by Green, second by Thornton, the Court approved line-item budget transfers.

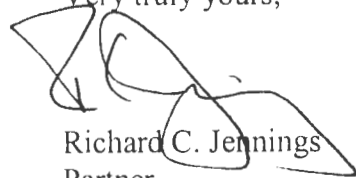
I have asked Bobby Stovall to deliver the two Letters of Credit for the first two phases of The Villages at Lone Oak. Please note that these letters of credit run for a period of 90 days which means that we have committed to build the roads within 90 days. If for whatever reason we are unable to complete the roads in 90 days, you will have the option of drawing on the Letters to complete the roads, or we will deliver to you other Letters of Credit or bonds to insure that the roads will be completed and maintained.

Regarding the amounts of the bonds, the calculations are as follows. For Phase I, there are 8,280 feet of roads to be constructed. Based on the attached letter from Vance Excavation, the cost estimate to prepare the road base for seal coat topping is \$16.50 a foot. Pursuant to the letter from Joe Sullivan, Inc., the cost to construct a prime and two coat surface treatment is \$7.84 a foot. Accordingly, a total per foot estimate is \$24.34. 8,240 feet times \$24.34 per foot equals \$201,535.00. Accordingly, the Letter of Credit for Phase I is \$202,000.00.

Regarding Phase II, there are 7,000 feet of roads, but approximately 2,400 of that amount has already received the rock base. Accordingly 5,300 feet needs road base and surface treatment. 5,300 feet times \$24.34 per foot equals \$129,000.00. 2,400 feet that only needs the surface treatment is \$18,600.00 (which is 2,400 feet times \$7.84 per foot). The total for Phase II is approximately \$149,000.00 which is the amount of the Phase II Letter of Credit.

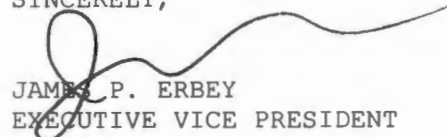

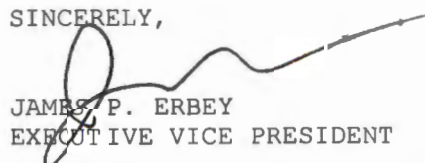

I would like to take a brief moment to update you on the progress the Environmental Enforcement Office has made since October 2003.

The office has made 403 calls for service. Of those calls 2 have been filed with the District Attorney. 4 have been filed with the County Attorney. 45 have been filed with the Justice of the Peace Erwin. 19 have been filed with Justice of the Peace Summrow. 10 have been filed with Justice of the Peace Reeves. 127 have been filed with Justice of the Peace Barnett. 196 calls have been listed as incidents, unfounded, and assists.

The work crew has abated 203 illegal dumpsites on our county roads. 51 in Prct. #1, 74 in Prct. #2, 45 in Prct. #3, and 33 in Prct. #4.

Along with these cleanups, the work crew has assisted or held cleanups throughout the county. There was 1 in Lone Oak, 2 in Celeste, 2 in Wolfe City, and 1 in Commerce. The work crew has also assisted the maintenance department, and has cut tires and chipped brush in various locations around the county.

The work crew has assisted the City of Greenville on several projects this June.

I would like to thank each of you for your support of the Environmental Enforcement Office. It is greatly appreciated.
