## COMMISSIONERS COURT REGULAR SESSION

May 23, 2005

The Hunt County Commissioners Court met this day at 10:00A.M.with all Commissioners present with Judge Joe Bobbitt presiding. Minutes of the previous meeting were approved as submitted.

## **NEW BUSINESS:**

— 'Discuss and possibly take action on approval of hazardous waste clean up report – Sara Allen, AG Extension:' The Court acknowledge report by Sara Allen of a successful clean up held April 23, 2005, which saved the County \$33,950.00.

9441 On the motion by Kenneth Thornton, second by Jim Latham, the Court approved award of bid for 2004 Texas Community Development Program, on behalf of North Hunt Water Supply Corporation, on the recommendation of Engineer Eddie Daniel of Daniel and Boone, to qualify bidder RJR Construction in Grand Saline, Texas for \$188,225.00, with an approximate completion date of 120 days. Mr. Daniels stipulated start date of approximately 2-3 weeks from this date to allow time to obtain Bonds and Insurance.

9442 On the motion by Ralph Green, second by Phillip Martin, the Court acknowledged the request of FEC Electric to construct electrical distribution facilities along and across CR 2276 and CR 2326 in Pct 2, with the usual stipulations.

9443 On the motion by Green, second by Latham, the Court approved renewal of contract of the lease agreement between Road and Bridge Pct 2 and A.L. Nelson, for approximately two acres, located at I-30 and Hwy 36 to be used as a road material stockpile. Commissioner Green stated contract would continue at same price and be due June 15, 2005. Agreement of Lease to be filed in Official Public Records.

9444 On the motion by Martin, second by Latham, the Court approved bid received for recycled asphalt, at different pit locations, to Recycled Aggregates in Ft. Worth Texas.

— 'Present and discuss safety award that was presented to Hunt County during the TAC Meeting in Austin, May 5, 2005:' The Court acknowledged receipt of Workman Comp Safety Award presented to Personnel Department. Hunt County received this award for nine consecutive years.

9445 On the motion by Judge Bobbitt, second by Latham, the Court approved proper notification of request of Wendall and Brenda Carver to deny County Health and Dental Plan coverage due to availability of another insurance policy. Delores Shelton – County Treasurer stated TAC request 100% participation in program, but until we drop to 90% it will not make a different. Furthermore, employees can only apply at Open enrollment time. Ms. Shelton to issue letter.
