PUBLIC HEARING

September 29, 2005

The Hunt County Commissioners Court met this day for the second and final Public Hearing to adopt the 2005-2006 Budget and to set the tax rate. All Commissioners were present, with Judge Joe Bobbitt presiding.

Chief Deputy Robert White was present stating Sheriff Anderson would like to not affect the bottom line of his budget and not to add the full time receptionist position, as earlier requested, to put \$20,000.00 in part time line item to hire another part time person, to help the other part time person already hired, and to place remaining funds in fuel budget to raise gasoline budget up to approximately \$100,000.00. This was approved by full consensus of the Court.

9570 On the motion by Philip Martin, second by Jim Latham, the Court adopted the FY 2005-2006 Hunt County Budget. Approved on unanimous vote. *See Attachment*.

9571 On the motion by Latham, second by Kenneth Thornton, the Court set the Debt Service tax rate for FY 2005-2006 at 4.9047 ¢ per \$100 evaluation based on a 100 % collection rate. Approved on unanimous vote. See Attachment.

9572 On the motion by Ralph Green, second by Martin, the Court approved the property tax be increased by the adoption of an M & O tax rate of .518487. Approved on unanimous vote. This tax rate will raise more taxes for maintenance and operations than last year's tax rate. The tax rate will raise taxes for maintenance and operations on a 100,000 home by approximately \$51.98. See Attachment.

9576 On the motion by Judge Bobbitt, second by Martin, the Court approved the Amended Budget.

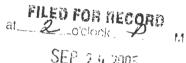

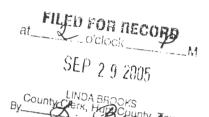

ORDER OF THE HUNT COUNTY COMMISSIONERS

COURT SETTING THE 2005 TAX RATE FOR THE

COUNTY OF HUNT, STATE OF TEXAS

WHEREAS, the applicable statutes of the State of Texas require an annual determination by the Hunt County Commissioners Court of the Tax Rate for Hunt County, Texas based upon the actual financial needs of the county for the year in which such tax rate is to be determined and set, as provided by Article 26.05 (a) and (b) of the Texas Tax Code;

AND WHEREAS, it has come to the attention of the Hunt County Commissioners Court from the statutory sources of information upon which it may rely regarding the financial needs of Hunt County for the current period beginning in 2005, that the tax rate for the year 2005 must be set according to law at 56.7534 cents per one hundred dollar (\$100) valuation, in order to meet the money needs of Hunt County under the law in the judgment of the Hunt County Commissioners Court, the same to be broken down by the proper authorities of this county into two components based upon needs for maintenance and operation and for payment of principal and interest on debt retirement for Hunt County;

NOW THEREFORE, this Court hereby ORDAINS AND ORDERS in a special session hereof that the 2005 Tax Rate for Hunt County be and the same is hereby ADOPTED on \$100.00 valuation for the tax year 2005, as follows:

\$.518487 for the purpose of maintenance and operation

\$.049047 for the payment of principal and interest on debt of this

County

\$.567534 TOTAL TAX RATE

BE IT FURTHER ORDAINED AND ORDERED, that the 2005 original Tax Levy for Hunt County is \$16,649,107.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE
AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$51.98.
