The Hunt County Commissioner's Court met this day at 10:00 A.M. in the Commissioner's Courtroom with all Commissioners' present with Judge John Horn presiding. County Auditor-Jimmy Hamilton and County Clerk-Linda Brooks were present. Commissioner Larry Middlebrooks gave the invocation.

11,768 On the motion by Larry Middlebrooks, second by Jim Latham, the

Court approved the minutes from the meeting held November 22, 2010.

NEW BUSINESS:

11,769 On the motion by Ralph Green, second by Kenneth Thornton, the Court approved

Flag presentation for the proper disposal of ashes for the American Flag for Eagle Scout Project of Caleb Donnenworth.

11,770 On the motion by Middlebrooks, second by Latham, the Court approved transferring

uniform allowance to quarter master program for Constable "Doc" Pierce, Pct 2. Mr. Piece

noted to the Court, this is a paper trail like other constables have previously done before.

11,771 On the motion by Green, second by Thornton, the Court approved application for grant

funding through the Texas Department of Transportation for the Hunt County Sheriff's Office.

Lana Adams stated to the Court, for a total amount awarded of \$19, 770.96, with in kind 25%

match of \$4,975.99. This is an overtime grant, which will target Christmas, Spring Break, and

the 4th of July to pay officers for DWI enforcement. The Court agreed to allow the County Judge to sign off to submit for these grants. *See Attachment*.

11,773 On the motion by Thornton, second by Green, the Court approved authorization of continuation of 2011 TCDRS Plan for Hunt County. *See Attachment*.

11,774 On the motion by Green, second by Thornton, the Court approved request to construct electrical power distribution facilities along and across CR 2538 in Pct 2.

11,775 On the motion by Middlebrooks, second by Latham, the Court approved request to construct electrical power distribution facilities along and across CR 3602 in Pct 3, with the usual stipulations.

11,776 On the motion by Middlebrooks, second by Latham, the Court approved request to construct electrical power distribution facilities along and across CR 3613 in Pct 3, with the usual stipulations.

11,778 On the motion by Middlebrooks, second by Latham, the Court approved annual award of Formal Bid #058-10, Janitorial & Paper Supply Contract, effective January 1, 2011 thru December 31, 2011 as per bid award, the lowest and best vendors, per recommendation of Carl Nicholl-Purchasing Agent. Bid on file in Purchasing Department.

CONSENT AGENDA:

11,779 On the motion by Middlebrooks, second by Green, the Court approved consent to renew annual contract for Psychiatric services for Hunt County Jail, effective December 1, 2010 thru November 30, 2011 with Psymed Solutions of Greenville, Texas for an annual costs of \$50,000.00 per year, as recommended by the Purchasing Department and the Sheriff's Office. Daniel Looney stated the Jail is happy with this group, plus the county is saving money in not having to go to Glen Oaks.

11,780 On the motion by Middlebrooks, second by Latham, the Court approved consent to accept the "First Amendment" to the existing T-NEXTIX Inmate Phone Contract for the purpose of adding "Prepaid" Calling Cards to the existing contract for the remainder of the contract term. *See Attachment*.

11,781 On the motion by Thornton, second by Green, the Court approved consent to accept completed drain project for the Hunt County Criminal Justice Center as per Contract #037-09. Final walk-through inspection completed December 6, 2010. Upon this acceptance of project, consent to pay final invoice from the contractor, We Build, and release bonds upon request of bonding agency. Carl Nicholl stated Judge Horn, Commissioner Thornton, Jimmy Moore-Maintenance Supervisor, representative from We Build, engineer from Walter P. Moore and himself were all present for the final walk through; it is the recommendation of this group to close the project. Mr. Nicholl has received We Build's final invoice in the amount of \$4,406.00; this project came in approximately \$1,100.00 under budget. As the County accepts responsibility for this project, then the bonding company will contact the Purchasing Department, stating all payment have been made, at that time they will be released from their bond.

11,782 On the motion by Latham, second by Middlebrooks, the Court approved consent to enter into Cooperative Purchasing Agreement with the City of Ft. Worth, Texas for the procurement of Commercial Credit Card Services from JP Morgan Chase Bank, presented by Carl Nicholl-Purchasing Agent. *See Attachment*.

11,783 On the motion by Latham, second by Middlebrooks, the Court approved consent to enter into Participation Agreement with JP Morgan Chase Bank for Commercial Credit Card Services. This agreement shall replace the existing agreement with JP Morgan which expires February 28, 2011. Carl Nicholl advised the Court, the State has elected to go with a new Contract with City Bank for this new contract; but contract does not look favorable to most of the smaller county or city entities. So, the City of Ft. Worth put out their own request for proposals for charge cards/credit cards to be used by their city. The awarded proposal was from Chase Group, which is who we are with now. We can piggyback, by this cooperative agreement, off the City of Ft. Worth's agreement. This will save us from having to go out on our own, which would be very difficult, due to our County not having the buying power that Ft. Worth has.

If we go this way, then we do not have to re-issue cards, with no banking changes, and no electronic changes. This will allow us to stay where we are, and we will still receive a rebate The Auditor and Treasurer have reviewed this and approve. All paperwork has to be completed and sent to Ft. Worth and then come back to Hunt County; then at that time, we will enter into the Participation Agreement. We don't want a time lag and loose any of our rebates.
