The Hunt County Commissioners Court met this day at 10:00 A.M. Commissioners Kenneth Thornton, Jay Atkins, Larry Middlebrooks, and Jim Latham were present. Judge John Horn was presiding. Tammi Byrd was present for Jimmy Hamilton, County Auditor. Jennifer Lindenzweig, County Clerk, was present. Carl Nicholl gave the invocation.

11,857 On the motion by Middlebrooks, second by Atkins, the Court approved the minutes from Commissioners' Court held February 14, 2011.

OLD BUSINESS:

11,858 On the motion by Atkins, second by Middlebrooks, the Court approved to action on renaming a section of County Road 2246 to County Road 2241 (approximately 1.9 miles) located off of S State Highway 34 in Precinct 2. The remaining section of County Road 2246 (approximately 1.15 miles) located off of W FM 1564 will remain County Road 2246. This change is required for 911 purposes and due to division in the road from a bridge being out – Jackie Ray, GIS Analyst.
