11,970 On the motion by Latham, second by Middlebrooks, the Court approved the award of the construction contract for the North Hunt WSC water system improvements project under the Texas Department of Rural Affairs grant contract #729341 to A + Water Works-Mirenda White-Harris, Kerbow and Associates Consulting, Inc. Presented by Eddy Daniel with Daniel & Brown Inc, Consulting Service. *See attachment*.

11,971 On the motion by Atkins, second by Middlebrooks, the Court approved to enter into an Interlocal Cooperation Agreement by and between Kaufman County and Hunt County for the housing and care of Hunt County inmates during periods that the Hunt County Criminal Justice Center's population exceeds the permissible numbers allowed by law at a rate of \$33/day, with the provision that we stay on top of this issue and to give Jimmy Moore the assistance he needs to get the annex ready in 30 days—Sheriff Randy Meeks, Jail Administrator Lee Greninger. *See attachment*.

During discussion with Sheriff Randy Meeks, with this agreement, Hunt County will pay Kaufman County \$33 per day as where we are currently paying Rains County \$40 per day per individual. We should receive compensation from the State on inmates being held over 45 days awaiting transfer to TDC; however we have never received any compensation. We are not the only county facing these issues. Judge Horn wants to utilize all inside resources prior to throwing money to other counties, wants the back up facility up and running in 30 days, it becomes the priority of the maintenance department, wants the Sheriff's Office administration to facilitate a meeting with the Judiciary regarding jail time, furlough, credit, and community service options. One of the things discussed before was not a fact of a spike in filed cases but a back log of inmates sitting in jail for various reasons. We are somewhat in an emergency situation that

throwing money at Kaufman County is not going to fix. Are we maximizing what legislature allows us to do on good time? We have got to look at our internal situation first. Hunt County money should be used to fix Hunt County problems, not Hunt County money used to fix Kaufman County problems.
