A. Consent Calendar:

11,983 On the motion by Middlebrooks, second by Thornton, the Court approved all items on the Consent Calendar as follows:

- 1. The addition of seized and awarded 29 ft. Texas Bragg Gooseneck Flatbed Trailer (VIN removed) to the Sheriff's Office inventory Sheriff Randy Meeks/Captain Lana Adams.
- 2. The donation to transfer a 29 ft. Texas Bragg Gooseneck Flatbed Trailer (VIN removed) to Precinct 3 to be used for official business Sheriff Randy Meeks/Captain Lana Adams. (Commissioner Middlebrooks noted that item #2 should read as donation to transfer.)
- 3. The addition of seized and awarded 16 ft. MFG Flatbed Trailer (VIN unreadable) to the Sheriff's Office inventory Sheriff Randy Meeks/Captain Lana Adams.
- 4. The donation of a 16 ft. MFG Flatbed Trailer (VIN unreadable) to the City of Commerce to be used for official business Sheriff Randy Meeks/Captain Lana Adams.
- 5. The allocation of \$700 of recently awarded seizure funds currently in holding status to the "Operating Supplies" line item of the Crime Control Budget to be utilized to purchase additional ammunition Sheriff Randy Meeks/Scott Grazer, Financial Controller.

- 6. The allocation of \$11,000 of recently awarded seizure funds currently in holding status to the "Equipment" line item of the Crime Control Budget to be utilized to install/upgrade/integrate surveillance systems in the Sheriff's Office Sheriff Randy Meeks/Captain Lana Adams.
- 7. The expense of recently awarded \$245 Wal-Mart Gift Card seized in game room raid Sheriff Randy Meeks/Scott Grazer, Financial Controller. Per Scott Grazer, the card will be used to purchase operating supplies.
- 8. The allocation of \$1,700 of recently awarded seizure funds currently in holding status to the "Salary Stipend" line item of the Crime Control Budget to supplement Corporal Blaine Roberts' salary for work currently being performed as night shift floor Sergeant until the end of the fiscal year Sheriff Randy Meeks/Lee Greninger, Jail Administrator.
- ___Commissioner Latham spoke of the use of seizure funds for both #8 and #9 of this consent agenda. Mr. Latham stated that he realized salaries are low but he stated that he would like for offices to take into consideration that it may not be possible to use seizure funds for salary stipends at times when budget shortages could not allow it.
- 9. The allocation of \$225 of recently awarded seizure funds currently in holding status to the "Salary Stipend" line item of the Crime Control Budget to supplement Claudia Alvarado's salary for work currently being performed as the Sheriff's Office receptionist until the end of the fiscal year Sheriff Randy Meeks/Captain Lana Adams.

The acceptance of a donation in the amount of \$150 in store credit from Rubbermaid to the Sheriff's Office for the purchase of inmate laundry baskets to be utilized to store inmate's belongings during incarceration in the Hunt County Jail Sheriff Randy Meeks/Lee Greninger, Jail Administrator.

11,985 On the motion by Horn, second by Thornton, the Court approved the reappointment of W.D. Hilton, Jr. as the Hunt County at-large board member for the Sulphur River Regional Mobility Authority for a two-year term effective February 1, 2011 thru January 31, 2013 – Judge John L. Horn.

11,986 On the motion by Middlebrooks, second by Atkins, the Court approved the bond and final plat for Tierra Redencion in Precinct 3 with the stipulation that road maintenance will be taken care of by the developer until he sells said property. This is a 3 year contract agreement that will be funded by the implementation of a transaction administration fee in the amount of \$2.00 per case. The approval of additional budgetary authority in the amount of \$60,000 for the Fuel and Lubricants line item of the Sheriff's Office budget due to rising fuel costs for the support of patrol activities – Sheriff Randy Meeks/Captain Lana Adams was dropped from the agenda after much discussion. Judge Horn discussed the necessity for all departments to cut back on their budgets as the process of budget hearings is about to begin. He encouraged Sheriff Meeks work with the Court by looking into other areas of his budget for a source of the funds needed for fuel. In addition,

Commissioner Atkins stated that the additional fuel costs needed could be taken from the Sheriff's Crime Control Budget. Commissioner Middlebrooks supported this idea and suggested the use of seizure fund monies as well. Item was dropped from the agenda..
