\_\_\_\_\_ Recognition of Constable Wayne "Doc" Pierce, Precinct 2, for outstanding service resulting in the nomination for Constable of the Year by the Justice of the Peace and Constable's Association of Texas-Commissioner Jim Latham, Precinct 4. *No action needed*.

12,002 On the motion by Latham, second by Middlebrooks, the Court approved a proclamation declaring June 2011 Caddo Nation Month in Hunt County, Texas-Judge John L. Horn. *See attachment*.

12,003 On the motion by Atkins, second by Thornton, the Court accepted the Hunt County Audit Report for FY 2010-Robert K. Lake, CPA, Rutherford, Taylor & Company, P.C. *Filed in the County Clerk's office*.

12,004 On the motion by Atkins, second by Thornton, the Court granted a variance request for on-site sewage facilities to be located on Duran Drive in Royse City, Texas-Jeannell Alexander.

12,006 On the motion by Middlebrooks, second by Latham, the Court approved the renaming of a section of County Road 3306 off of county Road 3304 in Precinct 3 to W County Road 3306 due to the bridge being out on County Road 3306. This is .1929 mile of dirt and .653 mile of oil sand to be changed in the County Maintenance System, and renaming the remaining section of County Road 3306 off of County Road 3305 in Precinct 3 to S County Road 3306. This is 1.0289 miles of rock to be changed in the County Maintenance System-Jackie Ray, GIS Analyst.

12,007 On the motion by Middlebrooks, second by Latham, the Court granted authority to hire two (2) temporary employees utilizing \$5,000 from the District Attorney's Forfeiture Fund and amending the budget accordingly-Noble Walker, District Attorney.

12,008 On the motion by Atkins, second by Middlebrooks, the Court approved/renewed the
Hunt County Investment Policy-Delores Shelton, Treasurer. *See attachment*.
\_\_\_\_ Very conservative policy, main concern in policy is to make sure the investments are

protected.

12,009 On the motion by Atkins, second by Middlebrooks, the Court approved/accepted the monthly Treasurer's Report-Delores Shelton, Treasurer. *See attachment*.

12,010 On the motion by Middlebrooks, second by Atkins, the Court granted permission to construct electrical power distribution facilities along and across County Road 3507 in Precinct 3 with normal stipulations-Farmers Electric Cooperative.

12,011 On the motion by Middlebrooks, second by Atkins, the Court approved the request to resubmit 2011 STEP Grant Application by Amazing Grants on behalf of the citizens in the Dixon Community-Judge John L. Horn.

12,012 On the motion by Thornton, second by Atkins, the Court approved a Statement of Concurrence by Hunt County regarding the application of the City of Forney to the FCC for use of the frequency 153.8675 adjacent to a current license held by Hunt County-Judge John L. Horn. *See attachment*.

12,013 On the motion by Middlebrooks, second by Thornton, the court granted budgetary authority to move within budget restraints of this budget year to cover shortfall in the Fuel and Lubricants line item of the Sheriff's Office budget to support patrol activities in light of rising fuel costs in an amount not to exceed \$50,000. Will come from other line items, not the general budget-Sheriff Randy Meeks.

\_\_\_\_ Proposal from Sheriff Randy Meeks to Commissioners is that we let this run into the red and then at the end of FY we will match half and request that Court match the other half. Hope it will not be as bad as we think it will be. Analysis by Auditor with the salary line item, coming/going of employees, we concur that there will be budgetary authority to make that happen. Original estimation was an additional \$60,000.00 to make it to the end of fiscal year. Will run into the red and match half so if \$20,000 we will match \$10,000 with the difference coming from the general

fund. Middlebrooks would recommend that we set a max amount liable for as Court. If want cap of \$50,000 the Sheriff would be agreeable to that. Thornton has problem with Court coming up with other half, if over on budget he has to find money in other line items in his budget and cut back on things to cover overages just as every office does. Can you move or cut from other lines to come up with shortfall. Auditor's projection if move from salary to fuel, or other line items would have enough to cover especially if a maximum \$50,000 is set. Sheriff would actually be covering whole amount of overages.

\_\_\_\_\_ The determination of whether or not a purchase order is required for items to be paid for from seizure funds-Sheriff Randy Meeks. Dropped to Old Business. *The liability issue needs to be resolved prior to putting back on agenda*.
