The Hunt County Commissioners Court met this day at 10:00 a.m. with Commissioners Kenneth Thornton, Jay Atkins, Larry Middlebrooks, and Jim Latham present. Judge John Horn was presiding. Jimmy Hamilton-County Auditor and Jennifer Lindenzweig-County Clerk were present. Invocation was given by Commissioner Middlebrooks.

CITIZENS TO BE HEARD

Mark Hemberger addressed the Court regarding the Court Appointed Attorney Fees. I have a spread sheet here. The average yearly income for most the attorneys here is in the 50s of thousands of dollars. But there is one firm that as a matter of fact really the fees amounted to over 800 thousand over budget. One firm that took up half of that is Renshaw Davis and Ferguson. They brought in nearly 400 thousand dollars for that year. Where everybody else except for just a very few were fairly nominal. What is so special about one or two firms that they can charge that much when everybody else is scratching for the crumbs. Then we have a newly elected District Judge, who did not even want an increase in his budget, but he got it anyway and people are raising cane about him using that to give his employees a raise. I figure he's trying to do the right thing. And what he does with it should be his business, just as District Judge Beacom business to use his raise for whatever he wants, but it seems like that somebody's being forced fed a budget that he doesn't want and that's not fair. I also have one other thing, how come you don't have any control over the court appointed attorneys fees but you have control over the budgets of the District Judge. Those are the questions that I have. Attorney Bob Scott responds to the court appointed attorney fees, court appointed lawyers are appointed by the Judges in each court room, their fees are approved by the judges, the commissioners court has budgetary authority to set the budget each year but they have no control over who gets appointed to what cases or what is approved.
