Pam Stringer addressed the Court. I moved into this residence 3 years ago to be out in the country. My neighbor has a contract with me, which he has already broken the contract but I don't have the money to sue him on it. He is trying to build an apartment building adjacent to my land which is like a mile off the highway like out in the middle of nowhere and he's trying to build an apartment building and he is already running a business out of his home which he is not even supposed to be doing. There are 12 to 15 boats over there now that he's rebuilding and he's got workers there. When we bought the land, he misrepresented it and told me my land was here and staked it off, but now he has moved it and most of my land is out in the road so I've got a very small section of land and then he's going to build an apartment building here and he's got 3 or 4 buildings this way. The original deed to the land says that he can't have but one mobile home or one structure with every 2 acres, no every 3 acres. The person on the other side who has asked me to represent him, Ronald Hill, has put up with his business running beside his home constantly but is totally against the apartments being built and we need to know what we need to do to stop that. All he's got out there at this time is a temporary electrical pole, he hasn't set up the electricity, but he has been measuring off the land and has moved his fence right up next to mine and I do not know where to turn at this point. I just want to stop the apartments and possibly stop the business being run out of his home.

Judge Horn can not respond but recommends she speak to the Civil Attorney, Daniel Ray, not for legal advice, but to at least get pointed in the right direction to try to deal with this situation.
