I make a motion that, in accordance with Section 111.008 of the Texas Local Government Code, the following Order is included in the Minutes of the Commissioner Court:

"This budget will raise more revenue from property taxes than last year's budget by an amount of \$ 972,574 which is a 4.48 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$ 570,677."

13,286 On the motion by Horn, second by Martin: In accordance with Section 26.05 of the Tax Code, I move that the property tax rate be increased by the adoption of a tax rate of 53.2469 cents per \$100 valuation, which is effectively a 2.96 percent increase in the tax rate. This tax rate will raise more taxes for Maintenance and Operations than last year's tax rate. The tax rate will effectively be raised by 4.94 percent and will raise taxes for maintenance and operations on a \$100,000 home by approximately \$49.40;

#### And

To set the Debt Service tax rate for FY 2014-2015 at **2.5089** cents per \$100 valuation based on a 100% collection rate.

#### And

To set the Maintenance & Operation tax rate for FY 2014-2015 as follows:

General Fund: 41.6842 cents per \$100 valuation

**R&B #1: 2.2592 cents** per \$100 valuation

**R&B** #2: 2.2507 cents per \$100 valuation

**R&B** #3: 2.2847 cents per \$100 valuation

**R&B** #4: 2.2592 cents per \$100 valuation

For a total M&O rate of: **50.7380 cents** per \$100 valuation based on a 95% collection rate.

"The total tax rate for the fiscal year beginning October 1, 2014 and ending September 30, 2015 is set at 53.2469 cents per \$100 valuation based on a certified tax roll of \$4,469,552,666."
