The Collaborative Adaptive Sensing of the Atmosphere (CASA WX) project is a multi-sector partnership dedicated to engineering revolutionary weather-sensing networks. The Purchasing Department recommends Ridgeline Instruments, Inc., the only responsive bidder. Price for services defined in Proposal \$478,000.00. Hunt County is applying for a federal grant through the Hazard Mitigation Grant Program (HMGP) which requires 25% matching funds to the federal contribution of 75%. The site chosen is atop Whitley Hall on the campus of Texas A&M University-Commerce. The University is providing the site, pedestal design and installation-to include installation of the radar, network connectivity, power and other considerations toward achieving the 25% matching funds requirement of the grant.
