"This budget will raise more revenue from property taxes than last year's budget by an amount of \$2,925,520 which is an 11.107% increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$994,176."

15,236 On the motion by Martin, second by Latham, In accordance with Section 26.05 of the Tax Code, I move that the property tax rate be increased by the adoption of a tax rate of 51.1899 cents per \$100 valuation, which is effectively a 3.81 percent increase in the tax rate. This tax rate will raise more taxes for Maintenance and Operations than last year's tax rate. The tax rate will raise taxes for maintenance and operations on a \$100,000 home by \$38.00.
