**RESOLUTION AND ORDER OF THE COMMISSIONERS COURT
OF HUNT COUNTY, TEXAS
FOR DECOMMISSION OF THE HUNT COUNTY JAIL ANNEX**

WHEREAS, pursuant to Texas Local Government Code 292.001 the commissioners court of a county may purchase, construct or provide by other means auxiliary county jail facilities if the commissioners court determines that the additional building or rooms are necessary; and

WHEREAS, the Hunt County Commissioners Court previously made such determination with respect to the Hunt County Jail Annex located at the intersection of Crockett St. and Stuart St. in Greenville, Hunt County, Texas (the "Jail Annex"); and

WHEREAS, the Jail Annex was previously used to house inmates, but is no longer used for such purpose; and

WHEREAS, the Hunt County Commissioners desire to decommission the use of the Jail Annex to house inmates;

NOW THEREFORE BE IT RESOLVED AND ORDERED, that the Hunt County Jail Annex is hereby decommissioned from housing inmates and shall remain so decommissioned unless or until recommissioned for such purposes by resolution and order of the Commissioners Court.

The Sheriff's Office has operated the Jail Annex designated as 2403 Crockett Street for a number of years. The building has been included in the Jail Inspections performed by the Texas Jail Commission.

The building was not in compliance during the previous Jail Inspection. The generator failed to meet the jail standard. The generator will not be repaired or replaced.

Currently the building cannot be used to house inmates.

It is requested the Commissioners Court pass a resolution to close the structure from being an annex of the jail.
