

Regarding the County Response to Covid – Daniel Ray, County Civil Attorney for a resolution to be drawn up on Covid Response Sick Time Pay Policy relating to Covid sickness and exposure

- 1. The County will adopt current CDC guidelines allowing the County policy to change as the CDC guidelines change.
- 2. If there are changes they will be sent to Elected Officials and Department Heads by the Human Resources Office working in conjunction with the County Health Department/Homeland Security Office.
- 3. If Covid test results come back negative then the employee will be paid based on sick time rather than the Emergency Disaster Pay for Covid.
- 4. If employee receives a positive Covid test and the CDC guidelines state to be out for a certain number of days that there is recognition paid to the fact that one of the long term symptoms of Covid is fatigue. Commissioner's Court would adopt a policy giving an additional 2 day policy consisting of 16 hours for anyone who needs to use it to be paid with the Covid Disaster pay instead of Sick pay.
- 5. Testing is required or allowed under the CDC policies that everyone who is taking time off due to Covid exposure or Covid illness be required to get tested subject to the CDC guidelines which provide some exemptions for people who have been vaccinated and that those test results be provided to the Department Head or the Elected Official who the person works for within 24 hours, and the Department Heads be told by HR that they are then to provide that information to the Treasurer, and the Treasurer's Office will determine how the pay works whether it works against sick time or whether it is in the special provision for Covid pay.
- 6. Unless the CDC guidelines that currently exists or that will be adopted in the future provide an exemption or exception that everyone who is taking time off for Covid exposure or Covid sickness be required to have the test and if they refuse to do so that they get paid based on sick time rather than DLWP.
