Bruce,

The Texas Legislature is consolidating Civil Fees and Fee Costs and has adopted Senate Bill 41 to assist counties in the standardization of costs statewide. These changes take effect on January 1, 2022. There are many components to the changes needed to our Odyssey software in regard to our fee codes and fee schedules as well as ensuring that our State of Texas efile configurations remain intact. I have been in communication with both Becky Landrum and Susan Spradling as well as the JP's and everyone is in agreement that this is above and beyond our internal capabilities for a restructure of our Odyssey configurations.

Tyler is currently offering individual packages to assist counties with making these changes. Below is a table of the associated costs:

The County Clerk will need the CC Civil and Probate for a total of \$5,250.00. (Becky doesn't think at this time that she needs the Juvenile package and Family doesn't have any associated fees)

The District Clerk will need the DC Civil and Family for a total of \$5,250.00

And the five JP Courts can be done with a Single Node package of \$2,625.00

I am requesting approval to use a minimum of \$13,125.00 and a maximum of \$15,750.00 in contingency funds to pay Tyler for assisting us in the Odyssey configurations. Once we have notified Tyler of our selected packages we would receive a Professional Service Agreement with their Statement of Work and schedule dates.
