That Robert Wyatt, as Principal, and United States Fire Insurance Company as Surety, are held and firmly bound unto Hunt County Commissioners Court Judge (and successors in office), as Obligee, in the penal sum of Five Thousand Two Hundred Twenty U.S. Dollars (U.S. \$5,220.00) for the payment of which sum, well and truly to be made, the Principal and Surety bind themselves, their heirs, executors, administrators, successors and assigns, jointly and severally, subject to and conditioned upon the following terms:

WHEREAS, the Principal constructed an asphalt road known as Elizabeth Way which is in the jurisdiction - namely Elizabeth Estates Phase 3, Lone Oak, Hunt County Texas - of the above mentioned Obligee; the construction of said road was completed on February 2, 2022, and accepted by the Commissioners Court on April 12, 2022.

WHEREAS, the Principal has given a maintenance guarantee for said road construction against defective materials and workmanship for the period of <u>2 years</u> after <u>April 12, 2022</u> (the "Maintenance Period") which may become apparent and for which Obligee shall notify Principal of during said period, and

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, that if the Principal shall well and truly comply with such guarantee during the Maintenance Period, then this obligation shall be void; otherwise to remain in full force and effect.

PROVIDED, that no right of action shall accrue on this bond to or for the use of any person or corporation other than the Obligee named herein, nor for any obligations pertaining to the Contract or the maintenance guarantee under said contract for any defective materials and workmanship which the Surety is not notified of prior to the expiration of the Maintenance Period regardless of when such defect(s) became apparent or whether they were incapable of discovery during the Maintenance Period; and

PROVIDED FURTHER, that the Surety shall have no liability under this bond unless the Obligee shall give written notice to the Surety by registered mail or certified mail, postage prepaid, at any place where an office is regularly maintained for the transaction of the Surety's business, of Principal's failure to comply with such guarantee postmarked prior to the expiration of the Maintenance Period.

each, its true and lawful Attorney(s)-In-Fact, with full power and authority hereby conferred in its name, place and stead, to execute, acknowledge and deliver: Any and all bonds and undertakings of surety and other documents that the ordinary course of surety business may require, and to bind United States Fire Insurance Company thereby as fully and to the same extent as if such bonds or undertakings had been duly executed and acknowledged by the regularly elected officers of United States Fire Insurance Company at its principal office, in amounts or penalties not exceeding: Seven Million, Five Hundred Thousand Dollars (\$7,500,000).

This Power of Attorney limits the act of those named therein to the bonds and undertakings specifically named therein, and they have no authority to bind United States Fire Insurance Company except in the manner and to the extent therein stated.

This Power of Attorney revokes all previous Powers of Attorney issued on behalf of the Attorneys-In-Fact named above and expires on January 31, 2023.

This Power of Attorney is granted pursuant to Article IV of the By-Laws of United States Fire Insurance Company as now in full force and effect, and consistent with Article III thereof, which Articles provide, in pertinent part:

Article IV, Execution of Instruments - Except as the Board of Directors may authorize by resolution, the Chairman of the Board, President, any Vice-President, any Assistant Vice President, the Secretary, or any Assistant Secretary shall have power on behalf of the Corporation:

- (a) to execute, affix the corporate seal manually or by facsimile to, acknowledge, verify and deliver any contracts, obligations, instruments and documents whatsoever in connection with its business including, without limiting the foregoing, any bonds, guarantees, undertakings, recognizances, powers of attorney or revocations of any powers of attorney, stipulations, policies of insurance, deeds, leases, mortgages, releases, satisfactions and agency agreements;
- (b) to appoint, in writing, one or more persons for any or all of the purposes mentioned in the preceding paragraph (a), including affixing the seal of the Corporation.

Article III, Officers, Section 3.11, Facsimile Signatures. The signature of any officer authorized by the Corporation to sign any bonds, guarantees, undertakings, recognizances, stipulations, powers of attorney or revocations of any powers of attorney and policies of insurance issued by the Corporation may be printed, facsimile, lithographed or otherwise produced. In addition, if and as authorized by the Board of Directors, dividend warrants or checks, or other numerous instruments similar to one another in form, may be signed by the facsimile signature or signatures, lithographed or otherwise produced, of such officer or officers of the Corporation as from time to time may be authorized to sign such instruments on behalf of the Corporation. The Corporation may continue to use for the purposes herein stated the facsimile signature of any person or persons who shall have been such officer or officers of the Corporation, notwithstanding the fact that he may have ceased to be such at the time when such instruments shall be issued.
