General Overview of project:

- There will be two locations on Rodeo Dr. where there will be an opening of a road in order to install a sewer line. The line will go from one side of the street to the other (per the attachments)
- The 2 locations where the road will be cut open in order to connect to a sewer line across the street will be from: 2844 Rodeo Dr. to 2845 Rodeo Dr. & 2800 Rodeo Dr. to 2791 Rodeo Dr.
- The plan is to cut the road open, with an approximate width of 23 inches, across the road of 26 feet, with the depth of the opening being up to 4 feet across the street.
- On 6/1/22, we were guided by Mr. Martin, the Precinct 3 commissioner, on the methodology to be implemented and materials to be used. He further instructed the contactors on what type of concrete and depth of concrete and other material to be used to allow cars to pass over the area without any damage to the vehicles.
- We also received instruction to make sure that the material and work to be done will be replaced by the same or higher quality materia.
- We are fortunate to have received his guidance and look forward to implementing the current plan.





That said Purchaser has deposited into a fund labeled "County Road Improvement Fund" the amount of \$ 24,446, 9/100 for the purpose of constructing a certain site improvement, to wit:

Upgrade of approximately 23/0 feet of CR5226 from Dit to RodL \$ 24,44600

To be specifically used for the improvements of the said road when adequate funding becomes available. The cost of said improvements shall be prepared by the Commissioner and agreed upon by the purchaser prior to the execution of this agreement. Upon receipt of payment, the County Treasurer shall forward a copy of the deposit warrant to the commissioner in charge of making said improvements. If for any reason the county has not completed said improvement within one hundred twenty (120) days from the date of execution of this agreement the escrowed road improvement funds shall, at the request of the said purchaser, be returned to the purchaser and this agreement shall then become void.

WHEREAS, said improvement is left to the sole discretion of the responsible commissioner.
