That said Purchaser has deposited into a fund labeled "County Road Improvement Fund" the amount of \$ 12,649.60 for the purpose of constructing a certain site improvement, to wit:

Upgrade of approximately 993 feet of CR 3229 from Rock to Oil sand. \$12,649.60

To be specifically used for the improvements of the said road when adequate funding becomes available. The cost of said improvements shall be prepared by the Commissioner and agreed upon by the purchaser prior to the execution of this agreement. Upon receipt of payment, the County Treasurer shall forward a copy of the deposit warrant to the commissioner in charge of making said improvements.
