PROJECT SCOPE = Phase 1

We understand that the scope of the project is to analyze the existing buildings on the Mary of Puddin Hill property recently acquired by the county. It is the intent of the county to convert as many of these buildings into municipal offices as possible. The buildings are a combination of load bearing masonry wall structures and PEMB structures. We will have a structural engineer analyze the structural integrity of the buildings.

The buildings to be reviewed are as follows: Retail Building, Bakery Building, Warehouse Building 1 and Warehouse Building 2.

GHC will scan the buildings using Lidar and point cloud which we will convert into a three-dimensional model of the structures for utilization of future architectural design work.

PROJECT SERVICES

- Civil Engineering will assess the site drainage
