



Carstensen Contracting, Inc. (CCI) is submitting this letter as a request for permission from Hunt Co. to cross CR 4618 as part of the Lake Ralph Hall Pipeline project.

CCI will be crossing the road per the attached project plans and specifications. Traffic on CR 4618 will be re-routed during the crossing work per proper TXDOT traffic detour signage. The work is expected to take approx. three days. During this time, the detour will be in place. The detour will be removed promptly after completion of the crossing. CCI will notify residents in the vicinity of the closure to inform them of the closure and detour in advance of the work.

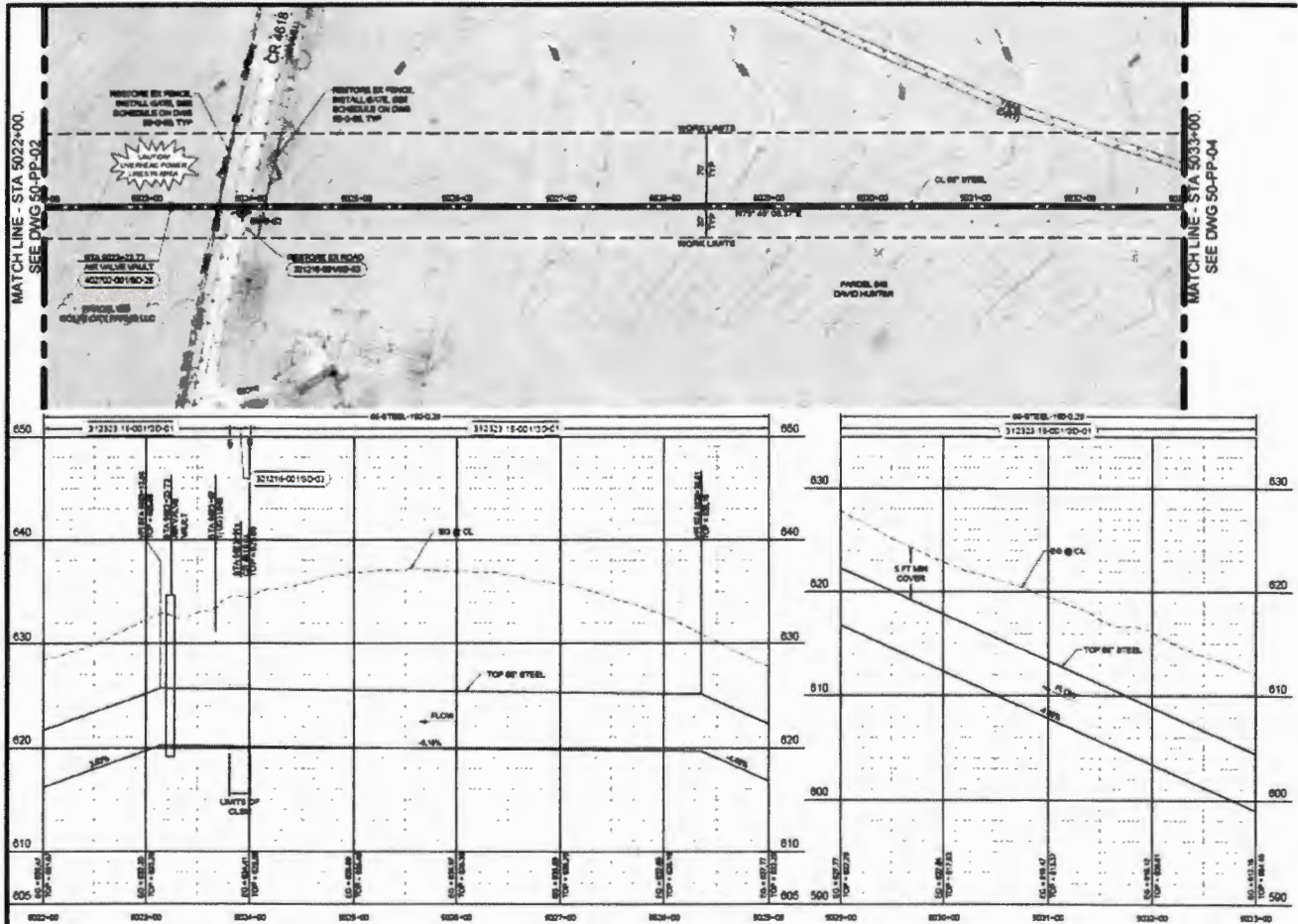

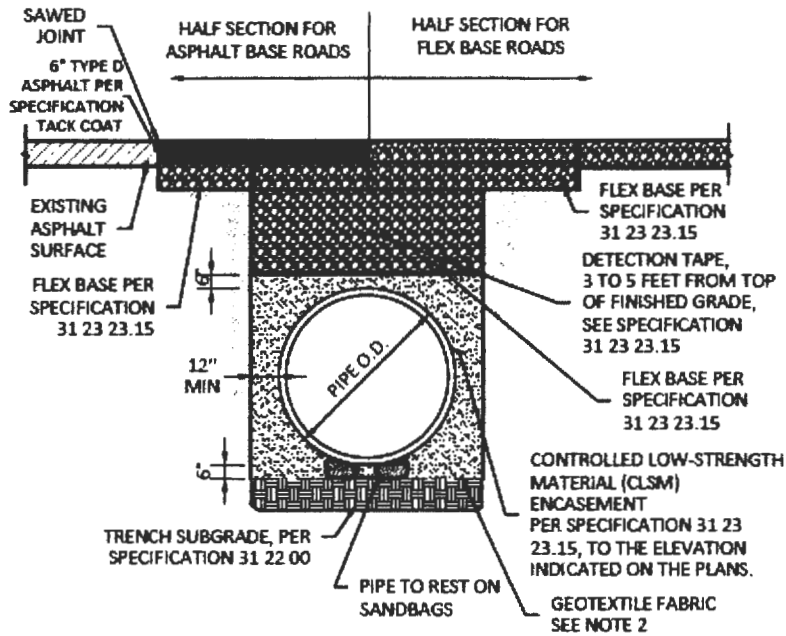
